

W-W board splits over Baracy's review

A divided Wayne-Westland school board has given School Superintendent Greg Baracy an outstanding evaluation for 2009-10.

The board voted 5-2 Monday evening to approve the evaluation. Trustees Carol Middel and John Goci cast the no votes.

"Our superintendent has shown his

devotion to the job and understanding salary," said Goci. "We had an evaluaof what is best for the students of this district," said board President Skip Monit, speaking on behalf of his colleagues who favored the review. "He is deeply committed and exhibits his dedication to this district on a daily

Goci, however, took issue with the evaluation and Baracy's contract.

"What happened with the contract? I expressed some concern about his

tion, but the contract never came up."

The board meet March 29 in closed session to conduct the evaluation which was based on two major topics — the high priority goals set for Baracy by the school board and his relations with the board, community, media and staff. The latter area also encompassed his professional leadership abilities.

The goals included the creation,

organization and completion of work by the district's 21st Century Schools Committee, which came up with the reconfiguration plan for the school district.

Businesses brace for fallout from smoking law

Michigan's law requiring restaurants and bars to be smoke-free starting Saturday has driven George Marvaso to the Internet for some research.

"It looks like the law will hurt us,

but then I think it will come back. That was kind of the word of mouth,' said Marvaso, owner of Marvaso's Italian Grille. "In Kentucky, California and other places where they've done this, business was down 25 percent at first. After things settled down, people came back. The restaurant,

which has had smoking and nonsmoking areas, may actually benefit from the smoking ban, he said.

"I'm not a smoker. People have said that they really like the restaurant and if it was nonsmoking, they would come in more," Marvaso said. "Smoking has more negatives than positives.

The restaurant has been open nearly eight years while Marvaso's adjoining business, the Electric Stick, has been open nearly 18 years. To change with the demand, the Electric Stick still has pool tables but much of its floor space is now devoted to tables for charity poker games that are held

"I think the restaurant could end up being better off with the smoking ban, it's the bar section that has me concerned," Marvaso said. "In the poker room, there is a no smoking section anyway. People can take a break and go to the other area to smoke. Now, they will have to go outside.'

In addition, Marvaso noted that the smoking ban exempts casinos and wondered about the impact on the charity poker games.

The new law is forcing changes at the Wayne-Ford Civic League, said Vic Barra, league president.

"It will definitely have an impact

State works to educate residents about new law

The Michigan Department of Community Health recently kicked off a Public Education Campaign to raise awareness on the statewide smoke free law, which takes effect May 1.

A large number of local community tobacco coalitions and health agencies are conducting presentations to community groups and businesses across the state about the specifics of the law.

"The smoking ban is a very important law that promotes health and protects residents from the dangers of secondhand smoke," said Janet Olszewski, MDCH director. "We are excited to partner with various groups and organizations to help educate the public and businesses about a law that will help us all live in a healthier environment."

MDCH has developed a Web site that communicates the details of the law, provides information for businesses on how to comply with the law, and contains affidavits to apply for the cigar bar and tobacco specialty shop exemption. The Web site also has a Frequently Asked Questions section that answers the most commonly asked questions about the smoking ban.

On Dec. 18, 2009, Gov. Jennifer Granholm signed legislation that prohibits smoking in public places, such as restaurants, bars, and hotels, or any place that serves food or beverages. The Ron M. Davis Law, named after the late chief medical officer of the Michigan Department of Public Health, makes Michigan the 38th state to ban smoking in public places.

The new law allows exemptions for the gaming floors at the three Detroit casinos, but the other casino bars and

eateries must be smoke-free, including the casinos' restaurants and hotels. Michigan's 20 American-Indian casinos are not covered by state law.

Cigar bars, tobacco specialty shops, home offices, commercial trucks and motor vehicles are also exempt. Businesses that are planning to file for the tobacco specialty shop and cigar bar exemption are encouraged to go to the Web site www.michigan. gov/smokefreelaw to obtain the proper

Due to provisions outlined in the law, affidavits and applications for the exemption will not be accepted prior to May 1, 2010. Individuals and business owners who violate the law will be subject to penalties of \$100 for the first offense and \$500 for subsequent offenses.

Glenn student remembered as 'giving' person

Friends and family planned to gather at the Cathedral of Faith Church in Detroit today to lay to rest an 18-year-old John Glenn High School student who died last Friday of injuries he suffered in an April 21 accident in Canton

Lance Lorenzo McKay II and his cousin were pushing his disabled car along Michigan Avenue near Hannan when they were struck by another car. The Inkster resident received aid from a Canton police officer before being airlifted to the University of Michigan Hospital in Ann Arbor. His cousin sustained less serious injuries in the accident which happened on westbound Michigan Avenue in the same vicinity of a two-car crash Sunday that claimed the life of a Plymouth teen.

McKay's death has been a blow to his family and friends. A fourth-year student at the Westland high school, McKay is remembered as a very giving person.

"He had a smile that would light up a room,"

said his father, Lance McKay. "He had so much respect for people and was totally giving of himself."

Gunmen rob cash advance store of money, phones

Westland police are looking for information on two men wanted for robbing a cash advance store at gunpoint and binding the clerk with duct tape April 23

An employee at Approved Cash Advance, 8367 N. Wayne Road, called at 11:20 a.m. after the she was able to free herself.

The clerk told police that two men were in the store as one of them filled out a loan application. When two other customers the only others in the store, left, the clerk said one of the men produced a black semi-automatic handgun. The suspect demanded the money from the drawer, the clerk said, along with grabbing

the cash on the counter that had been left by a previous customer.

The gunman walked behind the counter and began checking drawers for cash, the clerk said, then asked about the safe. The clerk said the gunman told her to come with him to the back where the safe is located and told his companion to follow.

Once in the back room, the clerk said the second man produced a roll of duct tape, bound her hands and feet with the tape before making her lay on her stomach on the floor.

Finding no more cash, the clerk said the suspects took all of the business's telephone headsets, the cordless phone and her cell phone

Goci also questioned the board's statement of Baracy taking a pay freeze this year when the district will be contributing 20 percent to his retirement.

"Retirement rates are set by the state and are for all school employees. Everyone is getting 20 percent," said Baracy. "You have no control of the retirement rate. It's state-mandated."

"One aspect of a board member's job is to evaluate the superintendent and give input," Baracy added. "If you don't like the contract, if you don't like my job, vote no."

While Goci maintained that talk of Baracy's contract never came up during the evaluation, board Vice President Cindy Schofield pointed out that he wasn't present.

"It came up, but you had left the meeting 35 minutes earlier," she told Goci.

Monit added that "there was no consensus among board members to extend the contract."

"The board was not motivated to discuss the specifics, it remains as is," he said.

Goci, in comments at the end of the meeting, pointed out that the "issue is salaries are too high with the total compensation."

"I'd really like to see us hire more teachers, I'd like to see us consolidate administrative positions," he said. "My issues with Greg Baracy's salary have been there since day one. To take pay freeze is not enough. I'd like to see him take a pay

Middel did not comment on the evaluation. When asked about her no vote, she said she "can't say anything because it

was a closed meeting." "I don't want to violate the Open Meetings Act, a lot of discussion happened in the meeting that I can't speak to," she said.

learned from the teen's cousin

that he had similar concerns. "He told me that Lance said, 'Pops is right," Lance McKay said. "He had decided he was

going to enlist in the Navy after high school. The teen was able to save several lives even in death, with

the family donating tissue, ten-

dons and organs to the Gift of Life for transplant purposes.

"He was a go-getter, always giving of himself, I'm so proud of him," Lance McKay said. "I loved him so much, I wish I could trade places with him. He was my heart."

Lance Lorenzo McKay II is survived by his parents, Lance and Jody McKay, sisters Leah and Avielle Kimble, grandparents Charles and Nancy McKay Jr. and Robert and Lois Selle, and several aunts, uncles and cousins. Arrangements were by Penn Funeral Home, Inkster.





Description leads to arrests for credit card theft

Two men, one from Canton and the other from Plymouth, have been arrested by Westland police for using a credit card reported stolen April 20 from a Livonia McDonald's Restaurant.

An ethnic description provided for one suspect helped officers track down the two men.

The incident began when a Westland man said that his wallet was lost or stolen at the restaurant on Farmington Road near Seven Mile. The man said he called to cancel a credit card around 10 p.m. and was told that someone had tried to use it earlier at the BP gas station at Wayne and Warren roads.

The man went to the gas station, he said, where he talked to the clerk who reported a young man had tried to use the card. The suspect gave the clerk the victim's driver's license along with the card telling him it was his father's identification. The clerk wasn't buying it and didn't let the man use the credit card.

The gas station clerk told the detective that the suspect had pur-

chased two cartons of cigarettes using a credit card, then attempted to make a second purchase exceeding \$100. That's when the clerk said he asked for identification and stopped the sale.

The suspect and a second man left with the victim's wallet, identification and credit card, the clerk told police. The clerk described the suspects as regular customers.

On April 26, the victim called police and reported being contacted by a man who said he had found the missing wallet and its contents. The caller wanted to arrange a return of the items. The Westland man said someone he believed to be a messenger returned the wallet contents except one credit card and the wallet itself.

The victim had the caller's telephone number, listed to a Canton man. The officer called the Canton man, who told the officer he knew the two men and would have them come to see the officer.

The officer obtained a mugshot of the Canton man and recognized him as the suspect shown on the gas station surveillance video using the credit card

video using the credit card. Later on April 26, the Canton man, 20, and a Plymouth man, 22, came into the station. The Plymouth man works at the McDonald's where the wallet was lost. He told the officer that another customer turned in the wallet but instead of contacting the customer or turning the wallet in, he decided that he and the Canton man should use the credit cards.

The Canton man told the officer he agreed with that account of the incident. He added that he had learned from a friend that police had his photo from the surveillance video.


The gas station clerk had described the Canton man as being Albanian. As a result, an officer who knows several members of the local Albanian community showed the suspects' photographs to one of those individuals. That person said he didn't know the men but the Canton man heard about the photos. The clerk was correct in his description — the Canton man listed his birthplace as Albania.

Both men were charged with fraudulently using a credit card.



Federal law protects from debt collector excesses

here is no doubt that in the current economic situation many people, particularly those in southeast Michigan, are having difficulties paying their debts.

Unfortunately, many people have had to make hard deci-

sions as to which debt to pay. The result is many people are being contacted by debt collectors either by the company that is owed the money or private debt col-

lection companies. Although most people who have not paid their debts are being treated properly, there are some who have been harassed by debt collectors.

Many people are under the mistaken belief that since they owe they have no recourse in dealing with the debt collectors. Not true. Even if there is no issue that the underlying debt is correct, debt collectors cannot harass you. You have

Under the federal Fair Debt Collection Act, debtors have rights. However, in order to enforce them you have to be proactive. Therefore, if you are in a situation where you feel that a debt collector is threatening or harassing, you need to exercise your right.

I encourage everybody to pay their debts and if they cannot. to work with creditors on a resolution. However, the fact that you do not pay does not give creditors and debt collectors the right to run wild.

Like all federal laws, the Fair Debt Collection Act is somewhat cryptic and difficult to understand. However, there are many places consumers can go to learn more about their rights. One place is www. ftc.gov. In addition, there is

Although it is impossible to discuss the entire act in this column, there are certain things that debt collectors are forbidden to do. For example, unless you agree otherwise, a debt collector can only contact you between the hours of 8 a.m. and 9 p.m. If a debt collector is contacting you after 9 p.m. they are in violation of the law. In addition, a debt collector cannot contact you at work or contact your neighbors, friends or family.

Debt collectors are also forbidden to claim they are attorneys (if they are not) or that they work for the government. Neither can a debt collector claim that he/she works for a credit reporting company or by failing to pay your debt you've committed a crime.

I've heard stories where debt collectors claim that if you do not pay the debt they can assess you with interest or additional fees. They cannot. Unless the original contract that deals with the underlying debt allows Rick Bloom is a fee-only financial this, there are forbidden to

assess additional fees. Many people are saying so what. If they violate my rights what can I do. I am already in

debt, therefore, I cannot afford to hire an attorney to enforce my rights. This is where the law helps individuals. Under the Fair Debt Collections Act, if an attorney does take a case and the debtor wins in court, the debt collector must pay your attorney fees. Because of this, more attorneys are starting to specialize in this type of litigation. If you are harassed or

threatened there are attorneys that will take your case knowing that they will be able to collect fees from the collection companies. Last year, there was a 60 percent increase from 2008 on the number of federal lawsuits filed claiming violations of the Fair Debt Collections Act. The bottom line is you have rights and they are enforceable.

Vote for Goci, yes on school renewal in W-W

On Tuesday, May 4, voters in the Wayne-Westland Community Schools will make two important decisions. They will decide who should represent their interests by filling a four-year term on the school board. They also will decide if the district should continue to levy its 18-mill nonhomestead property tax.

In the school board race, incumbent John Goci of Westland is being challenged by Karen Wilkie of Wayne for a four-year term on the school board. Both candidates voice concern about the future of the district and the decisions being made.

However, after interviewing both candidates and reviewing their responses to our written questions, we believe **John Goci** should be reelected to the school board.

Goci has done well during his first year on the school board. He has shown himself to be a man of his word and stands by his commitment to the children and to seeing that they get the best education. He is not afraid to vote no — as in the closing of six elementary schools and seeking concessions from employees to trim \$19 million from the district budget.

There is room on the school board for someone like Goci who will ask questions to bring to light information that he believes residents need to know. He provides an alternative view and a voice to residents who believe they are not being heard by the board.

However, if re-elected, we would like to see Goci be more involved. It's easy to say you don't agree; the hard part is offering constructive alternatives. We have yet to see the latter from Goci.

We also urge voters to **yes** on the renewal of the 18-mill nonhomestead tax levy. It's a win-win situation. The district will continue to receive the \$19.5 million the tax raises and it won't cost primary homeowners a single penny.

Renewal of the nonhomestead tax is a quirk of Proposal A. It is the one piece of the legislation that requires voter approval. Unlike the six mills levied statewide on primary residences, the nonhomestead tax is paid by the owners of commercial, industrial and some personal property. If it isn't renewed the district would have to make drastic cuts to balance its budget.

That said, we urge voters to re-elect **John Goci** to the school board and vote **YES** on the 18-mill nonhomestead tax renewal in the Tuesday, May 4, school election.

Re-elect King to LPS board May 4

Voters will choose between two candidates May 4 to fill a seat on the Livonia school board — incumbent Steve King and challenger Mark Johnson.

We encourage voters to re-elect **Steve King** to another four-year term.

Every board needs a dissident, and King has served that role well. He is the one board member most likely to express the opposing viewpoint and question the status quo. Often, he is the only one to vote no on an issue — although sometimes he is joined by Trustee Patrice Mang.

Some people call that negativity. But we think King's role on the board is healthy and helps lead to good governance. King isn't always right — sometimes the "facts" he cites are debatable — but he isn't always wrong either. And, some of the issues he battles other board members over aren't as relevant as others.

There are times King carries his dissident role too far. He needs to be less divisive and look for common agreement where he can. But he represents a segment of the electorate that otherwise feels unrepresented on the board. And, he has gained valuable experience in his first term, including learning how to more appropriately respond to those who disagree with his views.

We think King fills an important role on the board and is the stronger, more qualified candidate.



But for now, the accomplished 51year-old youth hockey coach finds himself killing penalties, the victim of a rare disease which required his right leg to be amputated below his knee.

In 2009, Jason was named Coach of the Year by both Michigan Hockey and the Michigan Amateur Hockey Association after guiding the Livonia Kings Midget BB state championship. In 2006-07, the popular coach with the gift of jab guided the Kings to the Midget B state title.

But last November, Jason's world was turned upside down when his

right skate didn't quite fit properly and he lost feeling in one of his toes.

Five surgeries later, Jason is now being cast and fitted for a prosthetic leg. And following his most recent operation (March 15) at Ann Arbor's St. Joseph Mercy Hospital, the selfemployed electrician is determined to get back on his feet.

"It's a vascular disease that is hereditary, it causes the arteries to harden and I had blockage to my main artery," Jason said. "I've been to hell and I hate to see anybody go through what I've gone though. Once a day I get angry and I go through all the whys?

"But as bad as it is, it can been worse and it can be fixed. I'm 50 and I still have a full life. Things are turning around and things are going forward, and we'll make it work.'



Choral group sings music by master composers

The repertoire is challeng-

The rehearsals are demanding — weekly for four months.

And the payoff lasts about

an hour each year.
But individuals for whom
"singing is their quality of life
and they are dedicated to it,"
join the Plymouth Oratorio
Society because they enjoy
performing classical music,
even if it's only at one annual
concert, says Richard Ingram,
who has directed the choir for
four years.

"It's a delightful group of people who come together each week to tackle hard music," he said. "Over 24 years they've built a reputation in the area. It's always fun to be able to work with a community chorus that has the ability to do this kind of music."

The choral group's 80plus members will sing Ralph Vaughan Williams' Benedicite, Nänie, by Brahms, and Dvorák's Mass in D, at 4:30 p.m., Sunday, May 2, at First United Methodist Church, 45201 N. Territorial, Plymouth. The Michigan Sinfonietta Orchestra will accompany the choir. Bonnie Kidd, Ingram's colleague at Huron High School in Ann Arbor, is the guest soprano soloist. Admission is free, although a free-will offering will be accepted.

Ingram selected the music, which includes two 19th century compositions and one piece from mid-20th century.

"The Vaughan Williams piece has great contrast. It's fast and loud and bombastic, but the middle section when the soprano comes in is very much more subdued," he noted.

The Brahms requiem is sung "mid-tempo" in German. The Mass combines slow and fast movements that make for an "exciting musical experience."

MASTER COMPOSERS

Don Pratt, Society business manager, said the classical repertoire sets the group apart from other community choruses.

"We don't use auditions, which surprises many people. We feel that the music we sing is the audition. Other groups do a lighter style concert, which is okay, but it's just not what we do. The other thing we do is sing with a professional orches-

tra. They are all professionals and that raises the level of our whole concert."

Pratt, a retired math teacher from Huron High School, and his wife, Kathy, have sung with the group since it began and have performed at every concert. The upcoming performance is especially significant because it's dedicated to his late father, Robert Pratt, who conducted the Plymouth Oratorio Society for its first nine years.

Pratt sang under his father's direction in about a dozen different choral groups through the years, including the Plymouth Oratorio Society.

"It was an honor and a privilege every time," he said. Pratt's mother also sang in the Society, his sister, who now lives out of state, has returned three times to sing a solo in concert and his oldest daughter sang for two


Pratt said the Society draws members from as far away as Jackson and Lake Orion. Many also sing in church choirs.
