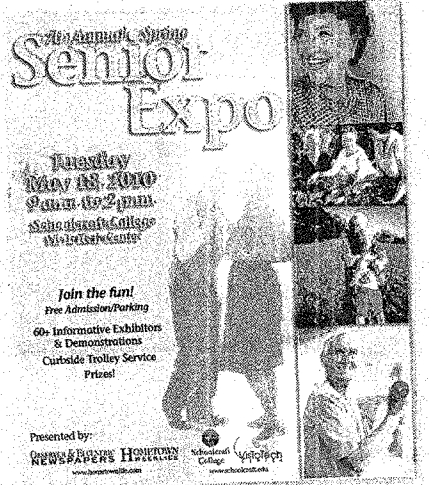

Last city union agrees to concessions

City supervisory employees have joined other Westland city workers in agreeing to concessions, including a pay freeze for the next two years.

The council recently approved a four-year agreement with UAW Local 174 representing 14 supervisory personnel. The agreement, which had been ratified earlier by union members, calls for pay freezes for the next two years with 2 percent raises in 2012 and 2013.

"I want to thank the bargaining unit. We were able to hammer out an equitable contract after two meetings," said Mayor William Wild. "It follows the other agreements and concessions."

Those concessions include the elimination of longevity pay and a uniform allowance, along with a cost saving change in health insurance for current employees and a different tier for new hires.

The contract also calls for new hires to be placed into a defined contribution pension program instead of

the current defined benefit program. Going forward, new employees will no longer receive post retirement health care benefits.

"It's a small unit but they take on a lot of responsibility," said Wild.

This was the last of the city employees to reach similar agreements. As with the other unions, supervisors will have the opportunity to buy up to five years generic time for an early retirement. Four supervisors who qualify for the program are expected to take the early retirement.

"I would like to express my grati-

tude to these employees who worked collaboratively to negotiate a contract that is reflective of today's challenging economic times," Wild said.

That comment was echoed by Council President James Godbout, who said he wanted to express his thanks to bargaining unit as well.

"You guys do a great job for us. You've stepped up like the other unions," he said. "It's not easy to make concessions but it saves jobs. Thanks for working on a solution."

Police officer has attachment to Westland's new police K-9

There isn't really any question that Westland police canine Officer Grant Allen develops a strong attachment to his dogs, he sort of wears it on sleeve.

Allen has the names of his first two dogs, Zeke, who is deceased, and Drago, who is recently retired, tattooed with an insignia on the inside of his right forearm. He soon will be adding the name of his new dog, Ty, a Belgian Malinois.

"I wanted to name the new dog

Diesel but he doesn't look like a Diesel, Ty just fits him," said Allen. "His name was Gaston but that reminded me of *Beauty and the Beast*."

Allen and Ty have started their required 280 hours of training that will be completed over a three-month period at the K-9 Academy in Wayne.

"Ty's great dog. He will be a full-service dog," said K-9 Academy owner Terry Foley, a canine officer with the City of Wayne Police Department.

Like his predecessors, Ty will

be trained for narcotics detection, tracking in buildings, area searches, obedience and working with a tactical team. The officer and dog also will make many public appearances at schools and various community events. There are 56 teams that train at the K-9 Academy — dogs and handlers from law enforcement agencies and hospitals.

"We want the most social dogs we can get — they are easier to train than ones with aggressiveness issues," said Foley. "The dog as no emotion about a suspect. He goes after someone because he has been

commanded, not because he dislikes or hates someone."

Like about 95 percent of dogs used in police work, Ty is a male. The reason most agencies use male dogs is the quicker recovery time after neutering — seven days versus a month, said Foley.

At 13 months, Ty weighs about 58 pounds and will likely reach a weight in the mid-70s when he is fully grown at three years old. That's about 10 pounds lighter than a German shepherd. Both Zeke and

Williams rejects plea deal in death of his wife

A Livonia man, charged with murdering his wife, is sticking by his decision to reject an offer to let him plead guilty to a lesser charge and take his chances before a jury.

George Williams, 33, was in front of Wayne County Circuit Court Judge Craig Strong Monday for the second time in less than a week. Charged with first-degree murder, which carries a mandatory sentence of life with no parole, Williams had been offered a sentence of 22 to 30 years in prison in exchange for a guilty plea to second-degree murder.

Williams, charged with murdering his wife, Sarah, 28, in the parking lot of Chatters Bar and Grill on Sept. 27, was in

court last week to enter a guilty plea but changed his mind.

"My client has had sufficient time to consider the plea offer and has decided to decline," said defense attorney Scott Nadeau. "His destiny is set in stone. He will go to trial."

Assistant Wayne County Prosecutor Rebecca Camargo outlined the plea agreement offered to Williams, adding this would be his last opportunity to accept.

"He's a grown man," said Strong. Williams was due in court Monday for a jury trial and pretrial hearing. Nadeau had filed a motion seeking to suppress statements Williams made to police officers following his arrest. Camargo asked

Two more W-W unions agree to concessions

Two more unions have received kudos from the Wayne-Westland school board for accepting wage and step freezes and an increase in health care costs.

Members of the Brotherhood of Specialized Skills (BOSS) and MEA Local 4 are the latest Wayne-Westland employee groups to negotiate concessionary letters of understanding with the district to help trim some \$12 million from the district's budget.

The employees have agreed to pay freezes and modest increase in the cost of health care — \$480 a year, or \$20 a month. They had contributed nothing prior to the agreement, Superintendent

Greg Baracy said.

"I want to thank BOSS and Local 4 for what they did," Baracy said. "I know it's a sacrifice and I hope this will get us through the next few years."

BOSS represents the skilled trades, such as plumbers and electricians, and has 33 members. Local 4 includes bus drivers, food service workers and custodians and has 297 members.

In ratifying the agreement, the board congratulated the two unions for "their generosity and foresight in taking voluntary reductions in compensation in the interest of the district and district families and students."

The two groups join the district's Central Office Administrators

Association, Building Administrators Association, Baracy and Deputy Superintendents Gary Martin and Charlotte Sherman in agreeing to wage freezes and increase contributions for health care.

The concession are being sought by the district are part of a multipronged effort to cut expenses and help the district weather the next two years financially without having to cut the educational program.

The first part happened in December when the school board voted to close six elementary schools and reconfigure its elementary program to create 11 K-four buildings and two five-six buildings. The reconfiguration will save the district an estimated \$5 million. The reconfiguration means the elimination of 60 positions, including principals, custodians and teachers as well as a savings in the cost of utilities.

The second effort is the employee wage freezes and increased contributions to health care, which would total another \$5 million in savings.

The agreements so far total 20 percent of the savings, and the district is in the process of talking with the Wayne-Westland Education Association which represents some 800 teachers.

"The teachers are the biggest piece with the pay and step freezes and an increase in the premiums for health insurance," said Martin, who handles the district's finances among other things.

He added that the administration is also looking at class sizes. Under the WWEA contract, class reductions were called for this year and next.

"It was a big issue during the strike," said Martin. "We went ahead with the reduction in 2009-2010, but would like to stop it at this year and not do 2010-2011. That would save \$1 million."

The board also has asked the administration for a 25 percent cut in central office staffing and the building trades and for cuts in supplies. Textbook and library book purchases have been put on hold and no new buses will be purchased. Participation in conferences also has been axed. Those actions will save about another \$5 million, Martin said.

Drago were German shepherds, the most popular type of police dog, followed by the Belgian Malinois.

"The Malinois is sleeker and smaller, they're built for speed," said Allen. "It's not the size of the dog in the fight, it's the fight in the dog."

Like Allen, Foley has had several dogs over his police career — dogs that live with the officer and become part of the family for the rest of their lives.

"We have a loving passion for animals and pleasing the public. We're able to give back," he said. "It's a 24-7 job. In police work, most officers can leave their work when they go home. Canine officers have to adjust their lives, their vacations."

"I just want to chase bad guys," said Allen. "There is the satisfaction of watching the dog work the streets, finding concealed dope the officers couldn't find and tracking robbers or burglars who would have otherwise gotten away."

Ty will be the fifth dog to work for the Westland Police Department. Currently, Officer Joe Bobby has a dog named Friday.

"The dogs have been beneficial to the department. They are cross-trained for

narcotics detection and tracking of people and evidence that might have been thrown into a field," said Chief James Ridener. "It's been successful on many levels — recovering people, evidence and drugs. And it pays for itself through drug forfeiture money."

After more than eight years in service, nearly 9-year-old Drago was still wanting to work, Allen said, but had lost stamina.

"Drago is playing the big brother role for Ty. He still wants to be first out the door when I go," said Allen, whose family also has another dog and a cat. "It's taking a bit for him to adjust to retirement. I'm having a retirement party for him at Malarkey's. He'll be there for the first couple of hours."

for more information on why the defense was seeking to suppress the statements.

"My client says that he was not in a sound state of mind when he made statements to police," said Nadeau. "He may have been intoxicated. He had a lot to drink — I personally don't see how he could have

been sober. That's up to the court."

Williams also contends that the officers ignored his requests for an attorney and continued the interviews, said Nadeau.

A May 28 hearing on the motion to suppress the statements has been scheduled. Williams, jailed since his arrest shortly after the murder, is scheduled for a trial beginning July 29.

More than a dozen of Sarah

Williams' family and friends attended the hearing.

Sarah Williams, a barmaid at Chatters Bar, had been married to George Williams just over one year. The couple had been arguing after George Williams came to the bar during her shift.

The autopsy showed Sarah Williams had been strangled but also suffered severe blunt trauma, including severe head and internal injuries and a large abrasion on her back

consistent with being dragged.

At an earlier hearing, George Williams' former wife testified that he had called and told her he had killed Sarah Williams. The former wife went to Chatters, found Sarah Williams fatally injured in the parking lot and called 9-1-1.

George Williams had fled the area and was subsequently arrested in Toledo.

helped the Alliance contain the threat to the Great Lakes posed by the invasive Asian carp, among other things, said Smith, a Detroit native. Alliance initiatives include education, coastal conservation, preserving beaches, sand dunes and urban habitats, contaminant cleanup and sustainable business.

Also on hand to support the cause was Lake Orion writer Bridget McGovern Llewellyn, author of the new children's book, *One Child, One Planet: Inspiration for the Young Conservationist*. Illustrated by the award-winning Carl R. Sams and Jean Stoick, the colorful hardcover picture book teaches children about the importance of conservation.

For each 6.2-mile, annual walk, Groves creates educational signs and posts them along the route. A few of this

year's "green" proverbs were:

- At least 36 states in the U.S. are expected to face water shortages within the next five years.

- One in 7 people lacks access to clean water.

- Two-thirds of the world's population is projected to face water scarcity by 2025.

It takes 5,000 gallons of water to produce one pound of meat.

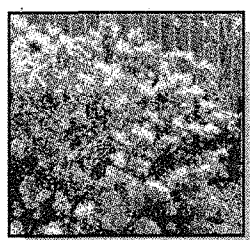

Detroit man charged in flower shop robbery

Strong arm robbery

Police were called to Westland Florist and Greenhouse, 34235 Ford, May 9 about a theft in progress. The shop owner told police he owns the building and his brother operates a computer shop in the adjoining space which can be accessed from the flower shop through an interior door.

Three youngsters, later identified as Detroit residents — one age 10 and two 12-year-olds — were at the counter asking for money while a man was standing near the door. Store employees reported calling the owner to the front of the shop after the youths began disturbing items on the counter and refusing to leave.

The shop owner said he noticed a third youth, age 10, leaving the door from the computer shop wearing a backpack. Since the computer shop wasn't open for business, the building owner said he grabbed the youngster's backpack.

At that point, the owner said he chased the youngster out the front door and around the parking lot. Then the store owner said he was confronted by a Detroit man and they

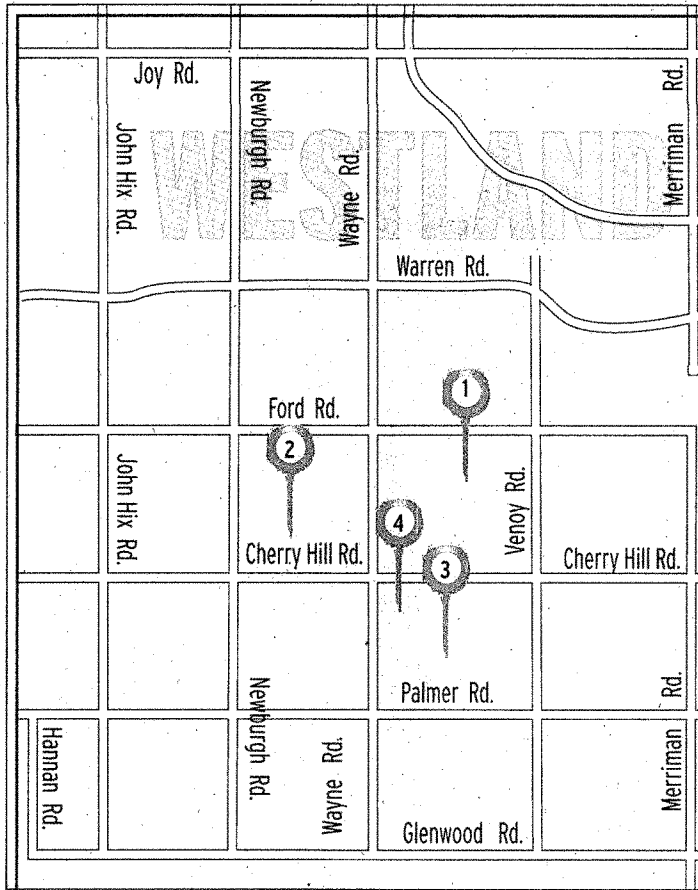
began wrestling, breaking the front window to the flower shop. The owner said the suspect took up a fighting stance, commenting, "Let's go." The owner was able to get the man inside the store by the time officers arrived.

One 12-year-old boy was taken into custody but the boys had fled on foot and were later picked up by Garden City police officers who turned them over to Westland officers. All three youngsters were eventually released to family members.

Three laptop computers, valued at \$700, were recovered from the backpack. The Detroit man was facing charges of larceny assault, contributing to the delinquency of a minor and vandalism after pulling an interior panel off the door on a patrol car.

Vandalism

The leasing manager of Hickory Woods apartments, 370 Hickory Lane, told police that he arrived at work May 9 to find that two clothes dryers had been damaged. Checking the surveillance video, the manager said a tenant was seen placing his clothes into two dryers.



When he returned, the clothes weren't dry and the man is seen becoming upset.

The video showed the man kicking the control deck of the dryer several times, damaging it. He then moved to the second dryer and kicked that control panel several times, also causing damage. The

video showed the man leave twice and each time return to do more damage to the dryers. The total damage was estimated at \$900.

The officer escorted the manager to speak with the tenant, who apologized and offered to correct the damage. He was ticketed and released.

Larceny

A resident in the 35000 block of Palmer told police May 10 that someone had stolen a tool box with 39 assorted tools and 25 compact discs valued at \$1,070 from his pickup truck while it was parked in his back yard. The items were last seen on May 8. The owner said the 1999 GMC pickup was locked but a window may have been left slightly down.

Retail fraud

Police were called to Kmart, 165 S. Wayne Road, May 10 after employees reported detaining two people for shoplifting. An employee told the officer a Westland man was spotted unwrapping two DVDs which he hid in the back pocket of his slacks. The woman, also a Westland resident, placed hair straightener and two bottles of shampoo in her purse. The pair then met up at the entrance and left without paying for the items, which were valued at \$79.

Vehicle thefts

A 2004 Ford Super Duty van valued at \$10,000 was reported stolen from a home in the 30000 block of Warren Road May 9. The vehicle, which read Cougar Contracting on the sides and rear, had a vehicle recovery

system. The unit showed the vehicle was at Hubbell and Puritan in Detroit. The owner reported recovering the vehicle with the assistance of Michigan State Police.

On May 7, a Livonia man told police that he had allowed his son to borrow his 1997 Dodge Caravan while the younger man's vehicle was in the shop. The son said the vehicle, which was paid for, had been stolen from the Waynewood Apartments, 6747 N. Wayne Road, where it had been left parked.

A 2002 Land Rover Discovery, valued at \$10,000, was reported stolen May 9 from a home in the 36000 block of McKinney. The man said he was current on the payments and had all the keys.

Solicitors

Police were called to the 7700 block of Ritz May 9 about man soliciting residents, asking to paint house numbers on the curb. The officer found the man, a Westland resident, walking on Ann Arbor Trail. He told the officer that Westland wouldn't give him a peddler license although he said he did have one in Dearborn Heights. He was ticketed for soliciting without a license.

Consider long-term goals, needs in investing

Who said being an investor is easy? Just when you think everything is getting back to normal, we have a week like last week. All of a sudden the fear that many people felt more than a year ago comes back in one day. Being an investor is not easy. Unfortunately, there is no easy way to go.

In the past, investors who were nervous about the market had some viable alternatives to consider. Many went with CDs and accepted the fact they would have lower rates of return in exchange for safety and security. In today's world, CDs are paying very low rates of return and do not keep up with the increased cost of living and cannot offer the same security as in the past.

Just about everyone recognizes that just to stay even you need to get greater rates of return than what CDs are paying. If you are saving for retirement five or six years down the road, you may be retired for 20-30 years. During your retirement, the cost of living will go up and as a result you'll need rising income throughout your lifetime. In that regard, CDs just don't cut it. The key is to invest

wisely. Many people may be asking what has caused the market to go south over the last few weeks. One reason is what is happening in Greece. There is a fear that Greece will default on their obligations. Although Greece only represents about 2 percent of the European economy, the fear is that if Greece defaults, there will be a domino effect.

Many European banks own Greek debt and if Greece defaults, these banks may then default on their obligations. In addition, the fear is there are other countries like Greece that have been fiscally irresponsible and may default on their obligations.

Greece has been on a financial roller coaster ride for a while and although a few months ago it appeared that the situation was resolved, it is once again causing uncertainties and fear. Who knows, another week from now the situation in Greece may be on the back burner again and things could get back to normal. Markets have a way of correcting themselves and sometimes it happens rather quickly.

As an investor you do not want to react based upon panic and potentially miss a significant run.

My advice is to maintain a portfolio based upon a strategy of asset allocation. That means allocating a portfolio within a variety of different

asset classes and then periodically rebalance back to your initial allocations. By using this strategy, investors should maintain a position in cash in order to cover short-term needs and emergencies.

The best possible protection for investors is achieved by maintaining an asset allocation strategy and having investments in a variety of different types of equity and fixed-income investments.

Keep in mind that whenever there is unusual volatility, the news media jumps to immediate conclusions. Unfortunately, these speculations generally turn out to be incorrect and as investors, reacting can be to our detriment.

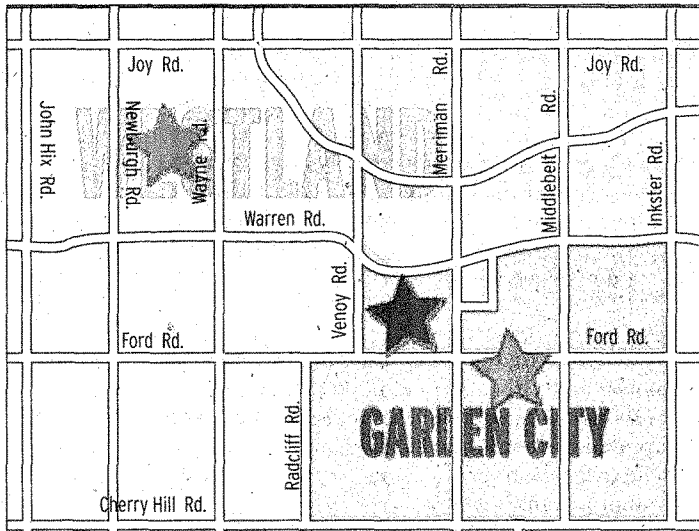

Trustee Middel oversteps role on school board

The Wayne-Westland Community Schools district is working hard at having its ducks in a row when the 2010-11 school year begins. A lot needs to happen between now and then and the district has strived to make the transition to a K-four-five-six elementary program a smooth one.

Unfortunately, the smooth ride hit a pothole with the appointment of Mark Cesarz as co-principal of Adams Upper Elementary School. It should have been a slam dunk. Cesarz's credentials are outstanding and he's got plenty of experience — almost 11 years as an assistant principal at Adams.

His appointment should have been a simple vote to confirm, congratulatory remarks and a thank you from Cesarz. But instead it became an embarrassment for Cesarz, who was put on the hot seat about his wages by Trustee Carol Middel.

Middel questioned the estimated \$6,000 pay increase Cesarz would receive as a co-principal, and asked if he would consider taking a pay freeze like what is being asked of other employees in the district. We thank Evelyn Baron, Michigan Education Association Uni-Serv director, who stepped up to represent Cesarz, a member of the Wayne-Westland Building Administrators Association, and put an end to the unfortunate exchange by pointing out that the pay issue should be discussed in closed session.

We are disturbed by Middel's actions. Since being elected to the board in 2009, she proven to be a capable and competent board member and has been consistent in siding with what she believes is best for the students, even if it has put her at odds with her fellow trustees. But there is no way to justify her behavior when it comes to Cesarz's appointment. It showed a complete disregard for the district's employment process and union contracts.

We can't slough it off as lack of understanding. She of all board trustees, a former member of the Wayne-Westland Education Association, knows what can and cannot be done by contract. As a board member, she also is aware the building administrators are covered by the W-WBAA contract.

Certainly, Middel should ask questions — that's something a school trustee should do — but she needs to know there is a limit to what she says and does.

To her credit, she did tell Cesarz she was sorry and that the discussion was never about him, but about the position. We disagree. The discussion was very much about Cesarz, and her apology was too little too late. Mark Cesarz is an experienced and capable administrator who deserved better.

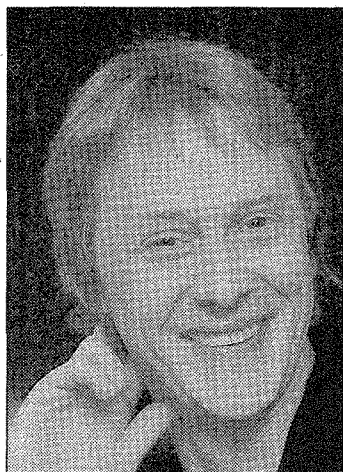

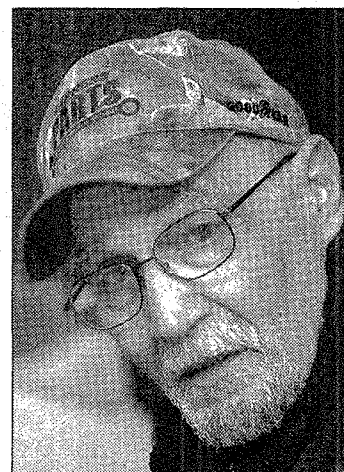

McCotter files for re-election in 11th District

A Livonia City Council member and former state lawmaker has entered the race in the state Senate's 6th District.

serve in western Wayne county," Toy said of Anderson who is running for reelection.

Anderson had failed to pass a single bill since entering office in 2007, she added.

Toy was elected president of the Livonia City Council in 2007.

A life-long Wayne County resident and graduate of Livonia's Bentley High School, she holds an associate's degree from Schoolcraft Community College and a bachelor's degree with a triple major from the University of Michigan-Dearborn.

The 6th Senate District includes Garden City, Livonia, Redford Township, and Westland.

Mosher to challenge McCotter in 11th District

When Canton's Natalie Mosher attended Barack Obama's inauguration last January with millions of other Americans from across the country, she had a hard time finding words to describe the experience. Less than four months later, she says the emotional event was the catalyst for her to get more involved in helping the country make a change.

The 65-year-old lifelong Democrat has announced she is running for Congress and will challenge Republican Thaddeus McCotter of Livonia, who is currently in his fourth term representing Michigan's 11th District. Mosher, who was born and

grew up in Detroit, has worked as a public school teacher and in the field of non-profits. She worked for the American Cancer Society when she lived in Ohio, and more recently was the chief development officer for the Detroit Riverfront Conservancy. She has lived in Canton since 2004.

If elected, Mosher said she would make healthcare, developing alternative energies, and

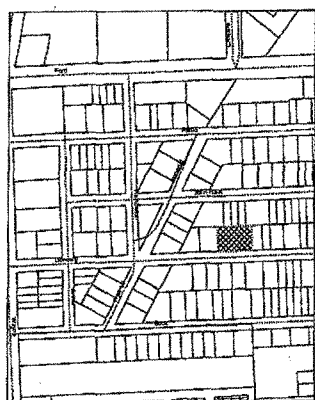
creating jobs her top priorities.

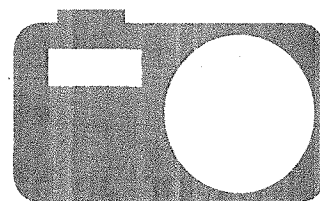
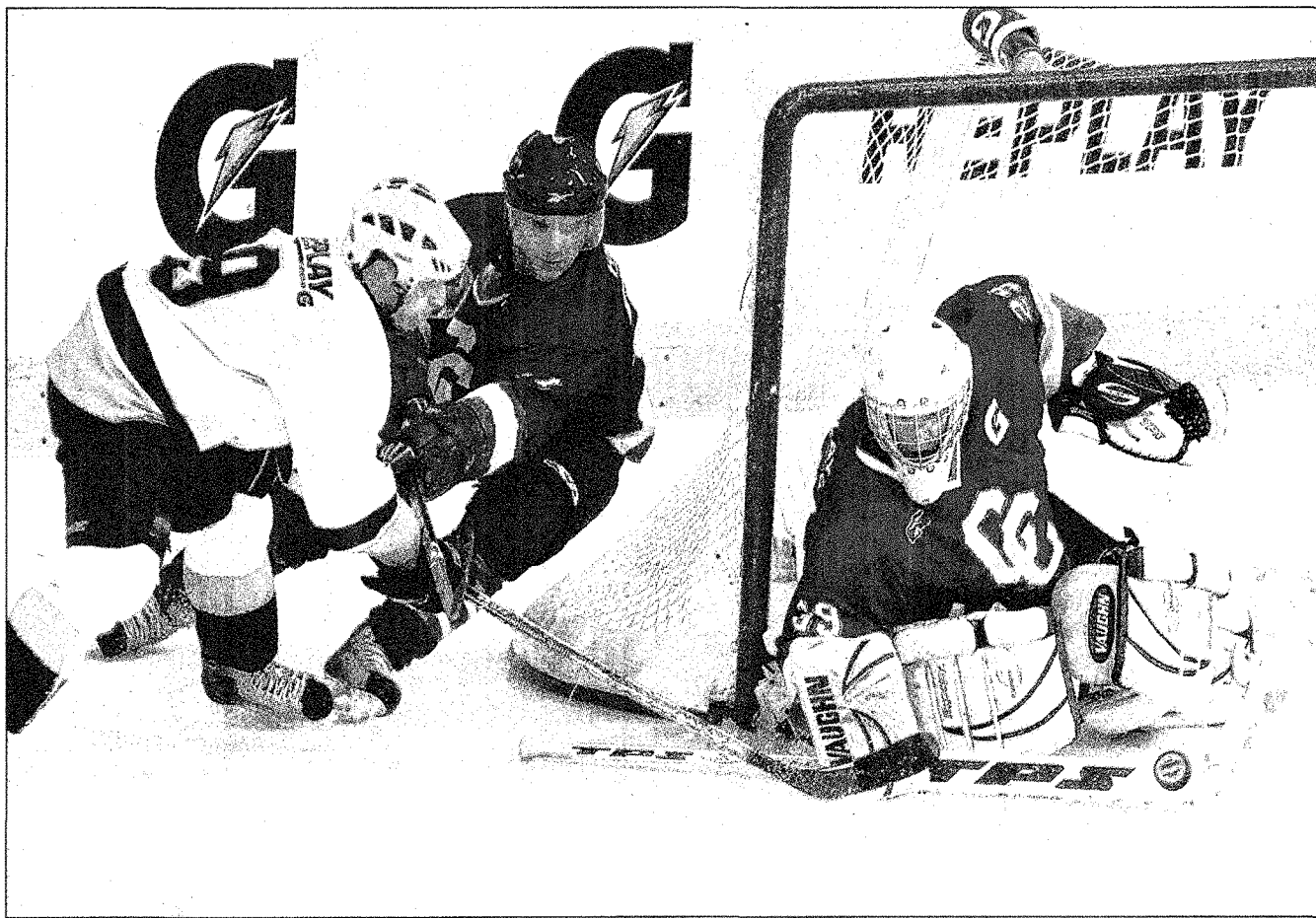

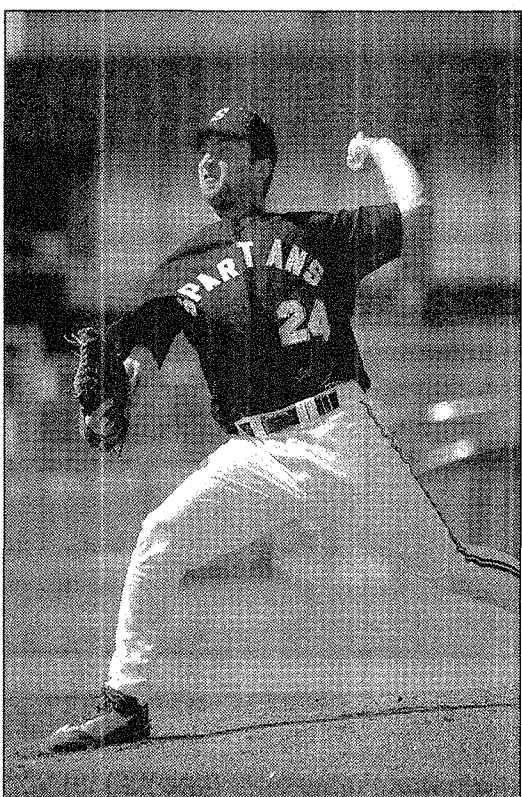

sion winners in each grade.

Hear music from the 1930s big band era to funky sounds of the 1980s

James Dignan loves musical variety — and he has three diverse bands to prove it. The Farmington Hills man manages and plays drums in The Classics, an all occasion band that performs tunes from the 1930s-1990s; The Belle Aires, offering favorites from the 1950s and 1960s; and Stardust Big Band, a 13-piece group that replicates hits from the 1930s and '40s.

“I’ve been playing drums since I was a child. I have learned to love a lot of different music,” Dignan said. “I didn’t want to get stuck playing one style.”

A practicing psychologist, Dignan formed his first group 11 years ago, adding the others in 2002 and 2005. They perform extensively at outdoor summer shows and for municipal music series, with The Classics also landing work at weddings.

He’ll bring all three together on the same stage this weekend for “Through the Decades: A Musical Journey.” The show starts at 7:30 p.m., Saturday, May 15, at Clarenceville High School, 20155 Middlebelt, Livonia. Tickets are \$12 in advance and \$15 at the door available through the bands’ Web site, www.cla6.com.

“I expect it to be incredible,” said Dignan, who staged a similar concert three years ago at the Redford Theatre. “I love the people that I share music with. I wanted us to do a real special show.”

Each band will perform 10 songs during its 35-minute portion of the concert. The Classics will focus on music of the 1970s and ‘80s, including such tunes as *Play that Funky Music*, *Brick House*, and *September*. The Bel Aires 1950s and ‘60s repertoire will include *Rock Around the Clock*, *Chantilly Lace*, and *Blue Moon*. Stardust Big Band will reproduce favorites from the 1930s and ‘40s, such as *In the Mood*, *Take the ‘A’ Train* and *Boogie Woogie Bugle Boy*.

ORIGINAL SOUND

Dignan said the bands play the original arrangements of the music and sound “very close” to the original groups that made the songs famous.

“It’s a chance to hear your favorite hits the way they were originally recorded.”

He’ll also show photos of the original bands through a PowerPoint presentation during the performance.

“It’s a very big effort. It’s fun and exciting

and you get all three bands,” said vocalist Nancy Oz, of Canton. “It’s going to be a great show.”

KARAOKE SINGER

Oz grew up in Livonia, playing flute and violin while in high school and in the wind ensemble while at Schoolcraft College, but hadn’t sung professionally until Dignan recruited her for The Classics and The Bel Aires.

“I never thought of myself as a vocalist,” said Oz, who is self-employed in the insurance business.

A friend of Dignan’s wife, Oz invited the couple to a Christmas party one year. She sang karaoke and Dignan said he might ask her to join the band one day.

“Never in a million years did I think that would happen. I thought he was just being a nice guest,” Oz recalled. When one of the lead singers quit, Oz joined the two bands in 2003.

“It’s so much fun. Most of the songs are older than I am, but I love that music. It’s fun, happy music.”

She still performs on flute occasionally, on such songs as *California Dreaming*, *Color My World* and *Under the Boardwalk*. She also bought a piccolo and took lessons.

“I play it on *Rockin’ Robin*. It’s the only song I play it on, but it was worth it.”

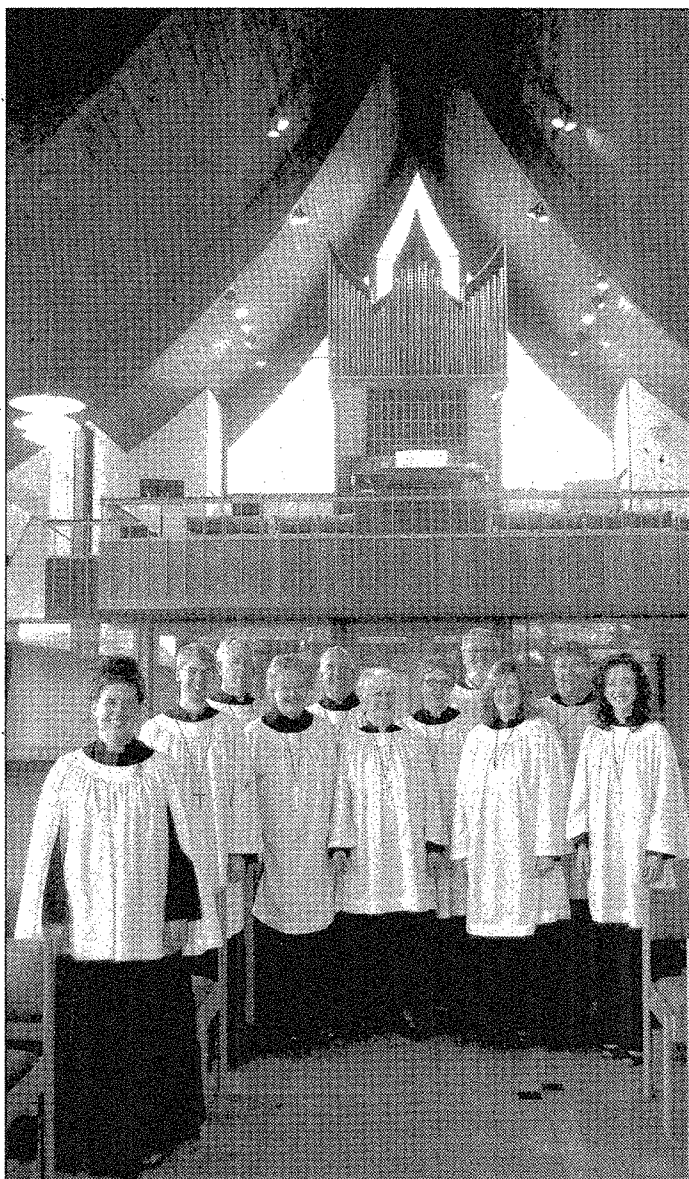

A musical story about the biblical Book of Job premieres at the Church of Jesus Christ of Latter-day Saints in Bloomfield Hills Friday, with encore performances set for Grand Rapids on Saturday and Westland on Sunday.

"You don't think about the Book of Job being a real finger-snapper," said Susan Mendenhall, public relations coordinator for the Westland Stake. But Mendenhall listened to a CD recording of the musical, written by Maureen Miles of Melvindale and performed by the Michigan Concert Choir and found "delightful music" and a story "everyone can relate to."

"This is in concert form. There is no scenery or special effects. It's a straight musical experience," Mendenhall said. "They have soloists, groups, individuals playing parts, with wonderful voices and all ages."

LABOR OF LOVE

Miles, a Latter-day Saints member in Dearborn, started working on the musical 20 years ago.

"I've written a lot of regular songs, Christian and country and I've written other musicals, but this is my masterpiece. It's probably my favorite Bible story. It's almost like a Cinderella story — they lose everything but get everything back in the end. God blesses you if you make it through the hard times," said Miles, a single mother of four grown children.

"I've been through a lot of heartache in my own life. In the Detroit area, with so much

heartache going on, it's the perfect time for this."

Miles started piano lessons when she was 8, began writing songs at age 12, and studied music at the University of South Dakota. She currently teaches music in Lincoln Park Schools, and as a motivational speaker gives workshops on "staying positive even though everything is falling apart around you."

FROM A SONG

The Job musical grew from a song she penned two decades ago.

"How would Job feel at the moment he lost everything he had? I thought that would make a good song. I wrote it and put it away for about 10 years."

But Miles, who loves writing about "positive attitudes" brought it out again and began rewriting, revising and expanding it.

Along the way, she used a little poetic license to create comic relief, adding characters, narration and a style that she says is more Broadway than sacred hymn.

"There are angels and devils. Job has crazy friends and they sing a comic song. His wife has friends who gossip. At the end of their song you have four melodies going at the same time and they sound like gossips. It's entertaining and funny to watch."

She said the levity makes Job seem more authentic.

"We tend to think of Job as a bent-over old man. Brian Dalling, who plays Job, is a relatively young man, tall and good looking. He makes the part of Job come alive."

Mendenhall's brother, Jim Jackson of Troy, plays Satan and adds a touch of humor to his character, Miles said.

Piano, organ and other instruments will accompany the 50-voice choir, which sings four-to-seven-part harmony on Miles' compositions.

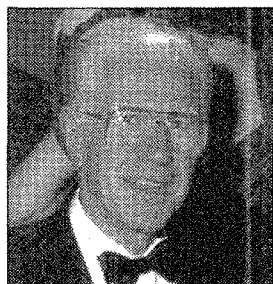

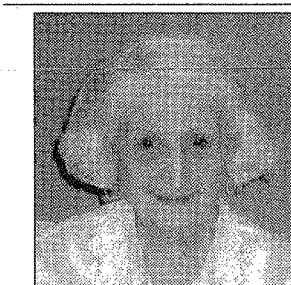

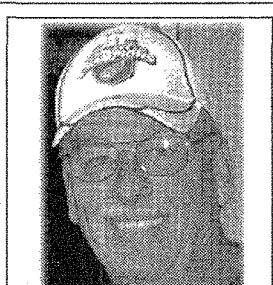
