### New homeowners get Bibles, tools from Habitat

The women scheduled to become owners of three new homes on Donnelly received the traditional Habitat for Humanity housewarming gifts — a Bible and a tool kit — at the dedication ceremony Tuesday.

"These ladies are really handy now. The homes are so well built that they won't need the tool boxes," said Alice Dent, executive director of Habitat for Humanity of Western Wayne.

Michelle Story, Torri Lewis and Amy Tracy will be the owners of the new homes on Donnelly east of Wayne Road. Westland acquired an abandoned home which was

demolished and the parcel divided into three lots. The homes received funding through the Neighborhood Stabilization Program and the federal Department of Housing and Urban Development.

"I'm proud to be here this evening to thank everyone — the sponsors, the churches and anyone who came out to support us with hands or hearts," said Lewis. "I want to thank God, who made it all possible. I thank you all for your time and your donations. I can't believe this came so quick. It's a blessing to me and my four children."

## Problems keep woman from getting Westland Habitat home

Ten months ago, Kenette Washington was expecting to celebrate Thanksgiving in the first Westland home rehabilitated by Habitat for Humanity.

Instead, someone else has purchased the home on Vincent. A single mother of two, Washington has been dropped from the program and is continuing to rent a home in Inkster.

"I was never told what the problem was. The woman there was giving me a hard time — giving me more and more hoops to go through," said Washington, a hairdresser and part-time store cashier.

Alice Dent, executive director of Habitat for Humanity of Western Wayne, agrees that there are many steps applicants must take before qualifying for a home that comes with a 20-year zero interest mortgage. But Dent disagrees that Washington was treated differently than any other applicant and adds that it's not unusual for people to reapply when they are initially unable to qualify for the program.

To qualify for a Habitat home, applicants must contribute a minimum of 250 sweat equity hours, pay an earnest money deposit and meet income guidelines verifying income and income to debt ratios.

"The government requires that all income has to be proved — we received HUD (Department of Housing and Urban Development) funds," said Dent, who couldn't speak specifically about Washington due to confidentiality rules. "If income is not verifiable, we can't approve the family for a Habitat home. I follow the rules — all that we do con-

sistent. I would not allow myself or the agency to be put in jeopardy."

Early in the application process, Habitat will accept a letter verifying the applicant's income. Copies of federal tax returns are required later in the process before the Habitat board gives final approval.

Having failed to file tax returns in 2006 and 2007, Washington said she had returns prepared for those years when she made

## Man faces trial in shooting at apartments

His face and hand still bandaged, a Westland man testified Thursday to being ambushed by a gunman as he returned to his apartment after grocery shopping the morning of Aug. 24.

Clifford Crain, 32, took the witness stand in 18th District Court in the preliminary examination of the man accused of shooting him, Antwaine Jeffrey Williams, 36, of Belleville.

"He pulled out a gun. When the gun came up, I turned to run. He fired and shot me in the face. I was turned so I

wasn't completely facing him," said Crain, who was shot in the face, arm and twice in the side. "I proceeded to run. He fired a couple more shots, maybe four. I heard them and felt them."

Crain tried to run through the Landings Apartments parking lot in a zigzag pattern, he said, pursued by the gunman but soon fell to the ground.

"He hit me in the back of the head. I could feel the butt of the gun hitting me in the back of the head," he said, adding his attacker had been holding on to him.

The attacker ran into a

## Father, sons charged with assault of teen

Three Wayne residents, a father and two sons, are facing charges for allegedly assaulting an Inkster teen near the closed Lincoln Elementary School on Sept. 13.

Westland police were called to the school site, 33800 Grand Traverse, at 5:40 p.m. about three men reportedly beating a fourth man with a stick.

When officers arrived the beating victim, a 17-year-old Inkster resident, was being loaded into a car by his friends and the suspects were gone, police said.

The victim was at the school playground with some friends, Westland police Sgt. Dan Serrano said, when there was a dispute with one of the suspects, a 16-year-old who was also there with friends.

Based on interviews, police were able to identify the suspects, who were subsequently arrested.

"The 16-year-old called his stepbrother for help. Dad ends up driving him and getting involved in the fight. He used the stick also," Serrano said.

The 17-year-old suffered no broken bones, Serrano said, but had facial injuries from being kicked in the head, soft tissue bruises on much of his body and a swollen knee.

"His knee was beaten as he was kicking to fight back. I saw him the next day and he couldn't walk. He was hit hard enough with the stick that he bled," Serrano said.

The two 16-year-olds are in juvenile custody, charged with assault with intent to do great bodily harm.

The father and stepfather of the juvenile defendants, Dante Guarascio, 47, was arraigned Thursday in 18th District Court on the same charge. A not guilty plea was entered for him and he was released on \$10,000/10 percent bond. A preliminary examination for Guarascio is scheduled for Oct. 7.

she wasn't able to express her appreciation to all of the volunteers so she had written letter and left it on the kitchen counter so visitors and volunteers could read it while touring the home.

"I'm so grateful that the neighborhood welcomed us and has been patient with the construction," said Tracy, who was meeting some new neighbors who stopped by to check out her new home. "I thought the sweat equity would be the biggest challenge but it was

getting all the steps done." Reflecting Habitat's origins as a Christian organization, a dozen area churches participated in constructing the three homes. Whirlpool Corp. provided appliances for the homes. The projects rely on donated labor.

Story's home was a Women Build project, sponsored by Lowe's, and the first home constructed by women locally in about 15 years.

A mother of five, Story partnered on her home with her mother, Jannie Story.

"Mine was the first home started. It was Women Build — thanks to all the women who volunteered," said Story.

"I've met so many people and families. It's like we have a new family."

The City of Westland and its Community Development Department have partnered with Habitat for Humanity as part of efforts to rehabilitate abandoned and blighted properties.

"It's hard to imagine that four months ago there was nothing here. Now there are three new homes and we are welcoming three families to our All-American city," said Westland Deputy Mayor Jade Smith. "We have had a long relationship with Habitat for Humanity and we applaud that."

Along with meeting income

guidelines to qualify for a 20-year interest-free mortgage, Habitat homeowners are required to put in a minimum of 250 hours sweat equity working on Habitat homes. Mortgage payments are used to fund construction and rehabilitation of additional homes.

"At the end of the year, we will have built or rehabilitated our 50th home in 15 years. That was our goal, so we are excited," said Dent. "We partner with families, we don't give homes to people. There has been about 1,000 sweat equity hours from the owners of homes on this street."

\$9,000 or less. She said her 2008 income of \$20,000 met the income requirements for the program.

"If you declare you have a \$25,000 income, we will ask for verification through a tax form. We are the eighth largest homebuyer in the nation," said Dent. "If a person can't prove that income, it's fraud. I could get arrested by the govern-

ment."

In addition, Dent said Habitat wouldn't set themselves up for foreclosures by approving sales to applicants who can't prove their income and won't be able to meet their mortgage payments.

Washington was upset that she wasn't aware of a problem until after she had expected to be in the house — she wasn't dropped until well into 2010.

"A program that works with someone for months has compassion," said Dent, adding that the board of direc-

tors makes the decision on whether someone is approved or dropped from the program.

The prospective owners of new Habitat homes on Donnelly include applicants who weren't accepted in the past but were subsequently able work out their issues to meet the program requirements, Dent noted.

That was no consolation to Washington, who remains

angry at Dent and Habitat, which has a motto of "A Hand Up, Not a Handout."

"It's been such a stressful situation. I got ill and had ulcers," said Washington, who got into a dispute with her landlord after giving notice when she thought she was moving. "I'm going to have a lawyer look at it. It was very unfair. I was sabotaged."

# Author invites dads to football tailgate party

Looking for a first book to read to your child? There are plenty out there. Colors, shapes, food, words, dinosaurs, numbers and animal sounds. There are even fuzzy sounds books.

But author Alex McNeece has written one geared for fathers and their sons that entertains and informs. He is introducing *Read to Me, Daddy! My First Football Book*, to fathers

and their children at a tailgate party in Garden City on Friday, Sept. 23, to promote father/child reading activities.

"This is meant to bring attention to the absolute need for dads to read to their children, we need dads to read to boys and girls," said McNeece. "A lot has been published about that idea and it's a great idea."

The party is being held at Douglas Elementary School on Hartel at Maplewood and includes hot dogs, chips and soda, face painting and balloons and the Michigan Youth Flag Football games, drills and prizes. McNeece also will do a book signing and sell copies of his *Football Book*, published by Nelson Publishing and Marketing, for \$6.

"It's not the focus of the tailgate party, it's to encourage fathers to read," said McNeece. "I want to promote literacy in the community."

The party ends at 7 p.m., just in time for fathers and their kids to walk across the street to the Garden City High School football stadium to watch the Garden City Cougars take on Redford Thurston High School for the discounted price of \$5 for themselves and one child.

This is the third book McNeece has written. The principal of the Lathers Early Childhood and Kindergarten Center, McNeece's first was a teen book, *Sam Iver: Imminent Threat*, followed by *Ryan and Ruby Go to Kindergarten*. He decided to venture into writing a sports book after growing tired of reading books about butterflies and such to his young son.

"One night, after reading to my son, I went downstairs

and decided to write a book I wanted to read to him," McNeece said. "There's not a bunch of books out there for dads to read to their sons."

The *Football Book* is two books in one. The story line is about a father who breaks out his all-time favorite football book to read to his son. However, each page includes a football fact, information McNeece unearthed in writing the book.

"I'm a huge football fan and when I researched the sport, I learned so much," he said. "So when I wrote it, I have a story on top for dad to read and facts on the bottom for only dad. There's some fascinating stuff out there."

There are even a few facts about reading and a list of other books for dads to read to their children.

According to McNeece, studies have shown that there's an achievement gap between boys and girls. For boys, achievement drops off at third grade while girls' achievement stays level. That's about the time boys' interest turns to topics like war that help prep their bodies for puberty. It's a time when boys need "high interest" literature to keep them reading.

"This problem has been on the radar for years and we're now starting to see books with video game themes and the like to interest boys," he said. "We're seeing the book selection widening. If you go to Amazon.com's teen page, you'll see 90 percent of the selections are for girls."

*My First Football Book* has been out since June and McNeece said if the demand for such books persists, he'll do more sports books. Granted, he believes football "is the greatest sport ever," but he's willing to take on other sports.

"I've been a coach and I've played for 15 years, if this gets dads reading I'll write until I'm run out of sports," he said. "I want to focus on dads and get them reading to their sons. The impact is so great, especially for boys."

"I read to my son every night, he loves the interaction," he said.

# Ford Road work has November end date

Michigan Department of Transportation officials made another appearance before the Garden City Council to discuss the Ford Road construction project. Wayne County Commissioner Diane Webb, D-Garden City, spoke on the Middlebelt Road construction project.

Both the state and county agencies are trying to coordinate the projects. Although MDOT officials said progress is underway, final completion is now estimated for about Nov. 10.

Some Ford Road businesses complained about blocked driveways and the length of the construction in general.

"We seem to be making some progress," said Mike Frankhouse, project engineer.

The project is divided into four phases. After the first phase, progress slowed because the contractor had issues with a subcontractor

and fired him.

The contractor is now working on the south side phase, the second phase of Ford Road.

"The driveways 'drive' this project," Frankhouse said. "Sometimes they take a little extra time because the businesses only have one driveway."

He expects that by the middle of October, half the job will be finished when they "top off" the road from Venoy to Henry Ruff.

"Then we will be pushing easterly (toward Inkster) into the next two phases."

MDOT officials agreed that when some business owners complained at a meeting last month, the roadwork had not gone as planned.

Mike Cleaver, a construction technician, said after talks with the contractor that extra crews were added. MDOT has had bi-weekly meetings with the contractor. Progress meetings are now being moved up to every week.

There also has been some discussion of adding another subcontractor to speed things up but those plans aren't firm.

"We're hoping to get 15 driveways done a week," Cleaver said. "There's a push to get the project done. We're keeping the pedal to the metal with these guys."

Cleaver said business owners were approached last year and asked if they wanted their driveways torn up if their driveways are new.

"One thing we noticed is that the driveways on the south side are smaller and will be quicker to pour, so that will help us out," Cleaver said.

Webb said she spoke to the project engineer for Wayne County about Middlebelt Road and was told construction of the intersection of Ford and Middlebelt Road will be left to MDOT just as the intersection of Merriman and Ford was.

The county will do Middlebelt north and south of Ford.

"Keeping traffic flowing

is important because you're going to have work going on both those roads," Webb said.

Garden City Councilwoman Jaylee Lynch thanked the representatives for not only hearing the concerns but also listening to them.

"We have the same common goals," Lynch said.

Frankhouse said that once the crews get past Henry Ruff, space for work crews will be tighter. "Drive slow and be aware of these workers," he said.

State Rep. Robert Constan (D-Dearborn Heights) has also been part of the Ford Road discussions in order to help get the project moving.

Webb reported that Warren Road from Merriman to Wayne Road is almost done, and the budget is set for construction on Warren Road east to Inkster in the next two years, she said.

"They won't start what they can't finish," Webb said.

"I looked outside and saw

Christian identified Williams as the gunman, adding that Williams had also struck the victim with the gun. After the gunman got into a pickup truck and fled, Christian said he called 9-1-1 after speaking with Crain.

Defense attorney Paul Rinaldi objected to Christian's identification of Williams. Shortly after the shooting, police drove Christian past a vehicle detained by Plymouth Township police on I-275 and he identified the driver, Williams, as the man he saw

Visiting Judge C. Charles Bokos rejected Rinaldi's argument, noting there was no requirement for police to hold a lineup. Bokos also rejected a defense motion to have the hearing continued and an expedited transcript prepared based on Rinaldi's complaint that he was unable to hear

Rinaldi was also unsuccessful in arguing that the testimony didn't support the charges.

No motive for the shooting was made public. Crain and Williams had never met, but Williams is married to Crain's former wife. Police said Crain and his former wife had been divorced for three years and had no children.

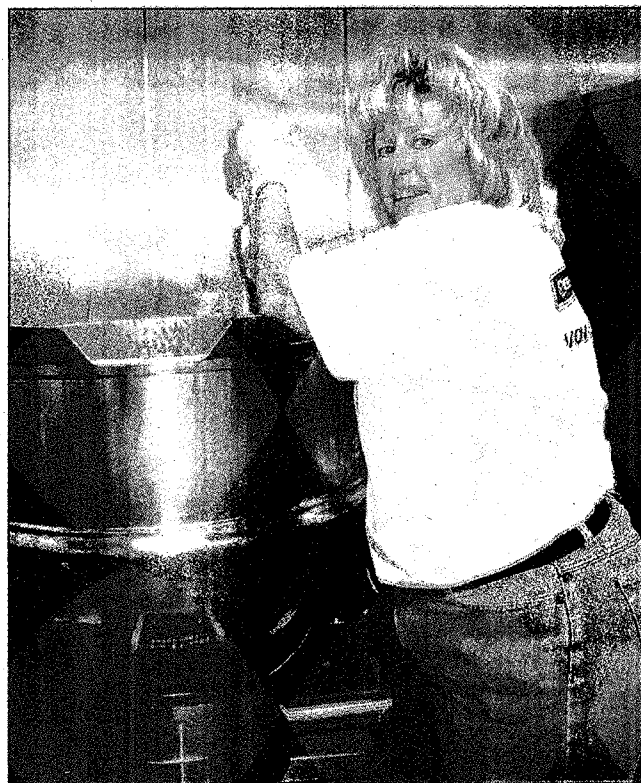

# Coping with Alzheimer's disease, dementias

Greg Lucky and Pat Martin, both Redford residents, are caring for ailing loved ones. Martin, 80, cares for her husband; Lucky, 56, both of his parents.

"We live together, one happy zoo," Lucky said of his family, including his parents, both 86.

They were together recently for a Caregiver Support Group meeting, sponsored by the Wayne Metropolitan Community Action Agency and held at The Village of Redford on Six Mile.

"It can be quite emotional," said Nancy Coman, senior services case manager for Wayne Metropolitan Community Action Agency, of caring for a loved with Alzheimer's or other dementia. "We come together and share with each other problems that may be occurring. They come together to learn coping skills."

On a recent Thursday morning, the group was joined by Julie Darocha, life enrichment coordinator for The Village of Redford, part of Presbyterian Villages of Michigan. Coman

talked about journaling as a tool to clarify feelings, getting a clearer view after a time of anger.

Martin and Lucky have been coming to the group at least three years, and heap praise on Coman. "She'll call and see if there's anything she can do," Martin said. Martin's husband, 81, is stubborn and difficult to deal with, so she has to make tasks "game-like."

Lucky said, "They're not easy to get along with," of his parents. He was living in California for many years and returned home when his parents became ill. Lucky's no longer able to work due to his family responsibilities.

His mom has advanced Alzheimer's and is totally dependent on him for care. Lucky's dad has other issues, including early dementia. "Everything is an argument, because he can't remember," Lucky said.

"I've had to learn patience," Lucky added. "It's my turn to give back to them."

Martin's son, in his early 50s, lives nearby and is a great help with his dad.

Her husband's an amputee,

missing part of his leg, so he crawls while trying to escape. "I've just come to accept that," Martin said.

Having company over is difficult. She insists her husband come to the table for meals, and he continues to enjoy his food. Even the family dog helps Martin, alerting her when something's wrong.

Coman has arranged respite care for Lucky's family. His mom had a stroke about 10 years ago, with her husband her initial caregiver. Lucky quickly realized that wouldn't work.

"He didn't want to tell me how things really were," he said of his dad.

At the meetings, also held at other community locations, Coman shares information on community resources.

"There are issues they experience on a daily basis," said Coman, who earned a bachelor of science degree from Madonna University and is a gerontologist.

Some people who have participated for many years are now caregiver-mentors for others. Often, such mentors have also been through hospice with their loved one, and want to help others earlier in the process.

"They know the whole process of caregiving," Coman said.

She has firsthand experience. Her dad had early onset Alzheimer's along with Parkinson's and cancer. Her late brother was ill and she cared for him, as she did for an aunt with congestive heart failure living out of state.

Coman, who also studied dementia at Madonna in Livonia, urges participants to get a diagnosis and secure power of attorney. She works with Wayne County Neighborhood Legal Services/Elder Law & Advocacy Center, which includes operations from the nearby Redford Community Center.

"I try to have an open atmosphere where they can share their emotions," she said of support group meetings. She often stays after meetings end and

people call her with concerns.

A spiritual component is included, and community resources include the local Alzheimer's Association.

She agreed elder care is a growing issue as the baby boomers reach retirement age. "Housing may become a difficulty," Coman said, as will finding caregivers to care for an aging population.

At the Caregiver Support Groups, offered free of charge to participants with Senior Alliance support, people are often caring for a spouse, sibling or parent. "It's a role reversal, that's another thing," Coman said of caring for a parent.

"Funding is tight really everywhere," she said of dementia research. "The University of Michigan is doing some wonderful research."

Isolation is often an issue for caregivers, she said, something the monthly support groups help to fight. She's looking into an evening group to draw in younger caregivers, who often have job conflicts during the day.

"We want to get the word out that there's help," she said.

One Caregiver Support Group, attended by Lucky, Martin and others, meets from 10 a.m. to noon the second Thursday of the month at The Village of Redford, 25330 W. Six Mile, Redford, in The Fireplace Room. Either the caregiver or recipient must be age 60 or older.

Also in Redford on the second Tuesday of the month, a group meets from 10 a.m. to noon at the Redford Community Center, 12121 Hemingway. There's also a group in Westland that meets from 10 a.m. to noon the third Tuesday of the month at the Kay Beard Building, 30712 Michigan Ave.

A Romulus group meets from 10 a.m. to noon on the fourth Wednesday of the month at the Romulus Senior Center, 36525 Bibbins.

Those attending for the first time are asked to call Coman at (734) 955-6752, ext. 228, as locations sometimes change.

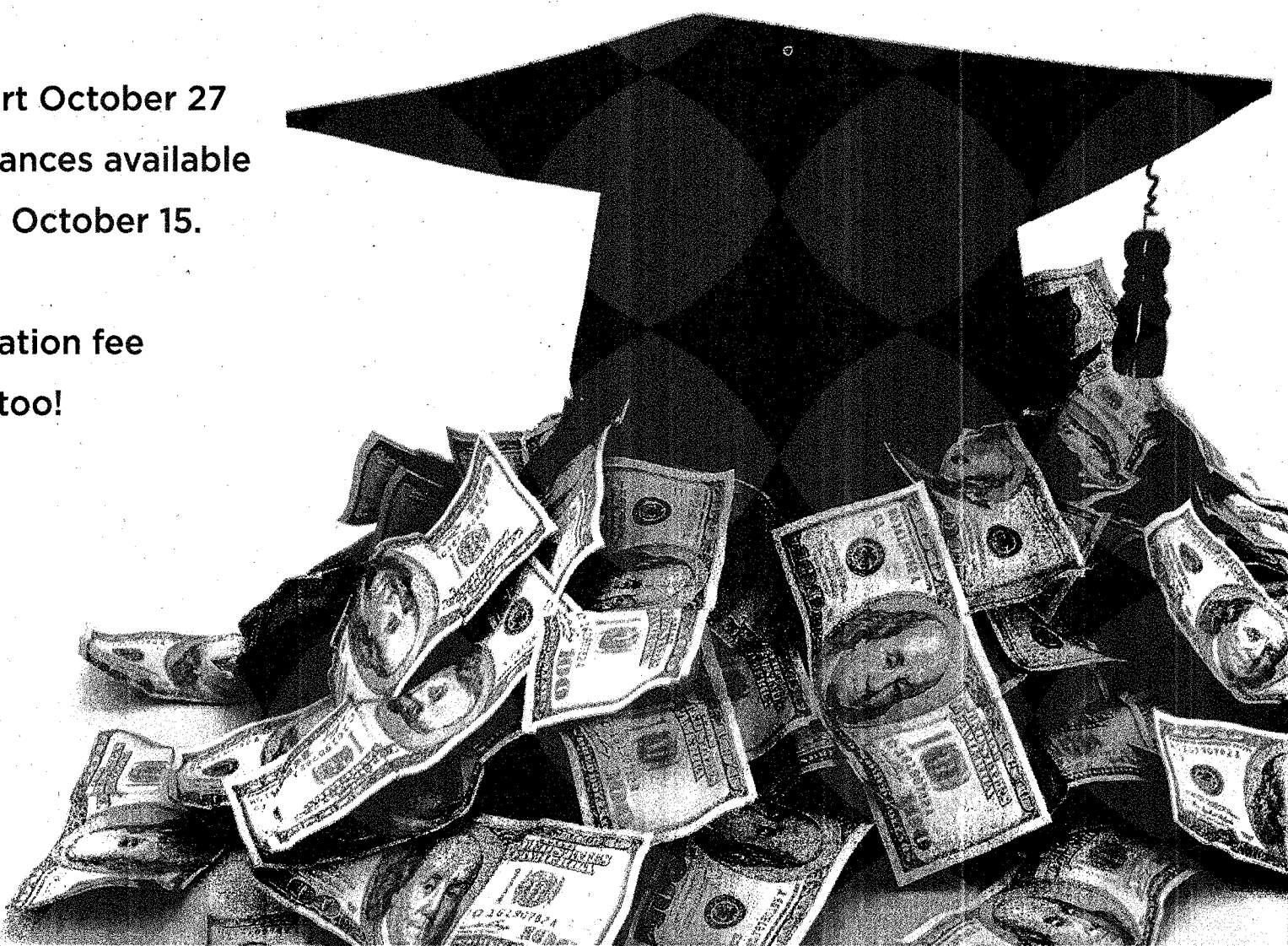

**A:** First, the bad news. The GM stock you own is virtually worthless. The issuance of new stock will have no effect on the shares you own. The stocks, even though they are both General Motors stocks, are from two separate corporations.

When GM went into bankruptcy it was divided into old GM and new GM. The new GM took the good assets and formed the new corporation. That is the GM that you see building and selling cars. The stock that GM is issuing in a few months reflects the new company.

The so-called bad assets stayed with the old GM and that company is still under the jurisdiction of the bankruptcy court. The stocks that you own and the stock options that you possess reflect the old company. This stock is virtually worthless.

In the future there may be some nominal value, but I doubt it. After all, that corporation is still in bankruptcy and its lia-

bilities far exceed assets. Once attorneys are paid and liabilities are settled, there will be nothing left, thus shareholders of the old General Motors will get nothing. Even if the new GM stock takes off, it will have no impact on the old stock.

Should you buy the new General Motors stock in the initial public offering (IPO)? Keep in mind the GM of the past, which at one time was the largest corporation in the world and for decades the largest automobile manufacturer in the world, is gone for good. The new GM, although having many of the same elements as the past such as Cadillac, Buick and Chevrolet, is a new entity with new management. From a financial standpoint, it is a mere shadow of its old self.

As much as I am rooting for the new GM to be successful, I have to look at things without emotion. Always remember that as an investor the goal is to make money. I believe the new company faces many challenges, making its new stock offering speculative at best.

Some of the issues affecting GM include the economy as a whole and increased competition at home and abroad. In addition, even after this initial public offering, the major shareholder will be the government. I am not one of those people that believe in conspiracies nor am I in any way anti-government. However, the reality is the

government's interest and those of ordinary shareholders can and do differ.

An example was recently disclosed in a new book, *Overhaul: Auto Triumphs of "Unshaven, Sockless Men,"* by former car czar, Steven Rattner. While General Motors was restructuring itself, the company decided it should move its world headquarters from Detroit to the Tech Center in Warren for financial reasons. According to the book, the Obama administration vetoed this based upon the economic impact on the city of Detroit. Shareholders of the corporation want the company to be a good corporate citizen, however, the bottom line is the bottom line. With the government involved, other issues, albeit important issues, may take more precedence.

At this point, I have a hard time recommending the GM IPO except to someone who wants to make a speculative investment — someone who can afford the loss if it occurs. There is no guarantee that GM will end up being a financial success.

Just because we hope or want something to happen, doesn't mean it will happen.

## McCotter discussed economy with auto suppliers on forum day

U.S. Rep. Thaddeus McCotter did not attend a candidate forum in Livonia Sept. 9 because he was in Washington, D.C., meeting with a senior vice-president at the Motor & Equipment Manufacturers Association, according to a press release issued Tuesday by the Wayne 11th Congressional District Republican Committee.

The purpose of the meeting was to discuss the current economic climate's impact on small auto suppliers and their access to credit, the press release said.

The press release was issued in response to incorrect statements made by McCotter's opponent, Democrat Natalie Mosher, about his whereabouts that day, said Carl Berry, chairman of the 11th Congressional District Republican Committee.

Mosher had issued a press release saying McCotter wasn't at the forum because he was "spend(ing) time with crooked lobbyists" at a conference in Washington, D.C., sponsored by the Faith and Freedom Coalition (FFC). McCotter did not attend the FFC Coalition. He was invited to address the conference the evening of Sept. 11, but he was unable to do so because he spoke at the 9/11 ceremony sponsored by the American Legion in

Livonia, Berry said.

McCotter's campaign office sent an e-mail to the League of Women Voters of Northwest Wayne County, which sponsored the forum, shortly after 1 p.m. Sept. 9 saying McCotter's official responsibilities precluded his attendance.

"Such things often occur when any organization chooses a date and publicizes a forum without confirmation from a campaign," the e-mail read.

Paula Bowman, president of the league, said the organization was disappointed. It had sent McCotter a "save the date" card June 25 and purposely scheduled the forum for when Congress wasn't in session, she said, adding he has attended past forums.

## Foundation sponsors veteran benefits seminar

Educating veteran advocates, and the estimated 400,000 veterans in metro Detroit, about benefits available from the Department of Veterans Affairs is the focus of a two-day seminar, sponsored by the Canton Community Foundation with the support of the Holbrook Charitable Trust.

Space is still available for the conference Sept. 21-22 at Laurel Manor and Conference Center, 39000 Schoolcraft, Livonia.

The first day of the conference will be devoted to the training of professionals who work for veterans, including attorneys, County Service Officers (CSO), Veteran Services Officers (VSO) and independent veteran advocates.

The second day, which is free of charge, will focus on Wayne County veterans, their families and the host of benefits available through the VA. Those benefits and programs include health care, disability benefits,

social services, housing, and burial.

As of 2009, the VA reported approximately 23.1 million living U.S. veterans, 8 percent of whom are women. But at an estimated 36 million, there are even more surviving spouses and dependent children of living and deceased veterans, who may be eligible for certain benefits.

In Wayne County, the VA spends an estimated \$400 million each year on veterans. Of that total, \$191 million is spent on medical care and \$154 million on compensation and pension payments, according to the VA.

"I have seen the confusion among veterans and their families about what benefits are available to them," says Jim Fausone, CCF board member and program chairman.

Legal advocates and attorneys will also have the opportunity to earn continuing education credits with par-

ticipation in the conference. In Wayne County, 46 attorneys and 103 VSOs are accredited by the VA. Continuing education is required to maintain accreditation. Similar educational programs are not available currently in the metro area, Fausone said.

"This conference is an opportunity for everybody who is a veteran stakeholder to gather," added Fausone, a partner with Fausone Bohn PLLC. "It's a chance to build relationships and contacts so veterans can be referred to the best resource."

Pre-registration is required for professionals, and veterans and their families. A continental breakfast and lunch will be served both days of the conference. Registration for attorneys is \$125. Registration for veterans is free. Registration may be completed online at [www.cantonfoundation.org](http://www.cantonfoundation.org) or by calling the CCF at (734) 495-1200.

# Franklin rebounds to defuse Rockets, 28-6

Bruised and battered from a 41-0 pounding the week before by area juggernaut Canton, the Livonia Franklin football team proved resilient Friday night with a 28-6 victory at Westland John Glenn.

The Patriots, missing starting running backs Brandon Tower and Jimmy Mazaris to injury, plugged their holes as fullback Dan Muller rushed for 127 yards on 21 carries and backup Tino Benavides added 102 on nine attempts to improve to 3-1 overall and 1-1 in the KLAA's South Division.

Quarterback Brent Marzion also proved to be efficient as he completed 9-of-13 passes for 95 yards and one touchdown, a 24-yard strike to Mike Sharp with 8:12 left in the first half to give Franklin a 7-0 advantage.

"We challenged the offense at halftime," Franklin coach Chris Kelbert said. "The defense was keeping us in the game. The offense was kind of bringing us down a little bit so we challenged them in the second half. They (Glenn) were overloading with our strong side — so we took advantage of that. We went with what we knew we could do. We just had to fill the guys in. Tino Benavides

filled in nice for us."

Franklin picked it up a couple of notches during the second half, getting a 52-yard TD run by Benavides with 2:58 remaining in the third quarter, followed by a 13-yard TD jaunt by Muller to make it 21-6 with 6:18 remaining in the final quarter.

"It was 7-0 and we had to bring it quick," said Muller, a 6-foot, 195-pound senior who also starred at linebacker. "We had to bring up the intensity. We had to go. We knew they (Glenn) were going to come out the second half. We knew what we had to do, we just had to execute it."

Sandwiched in between Franklin's two scores was a 12-play, 92-yard TD drive by the Rockets, capped by Donnell Brewer's 3-yard run with 10:15 remaining in the game. But Glenn botched the extra-point attempt with a low snap as holder Mark Layne was tackled short of the goal line to make it 14-6.

During that drive, the Rockets used running back Rico Cole (15 carries, 64 yards) out of the Wildcat formation.

"We couldn't get into a rhythm," said Glenn coach Tim Hardin, whose team slipped to 2-2 overall and 1-1 in the KLAA South.

The two have known each other since 1965.

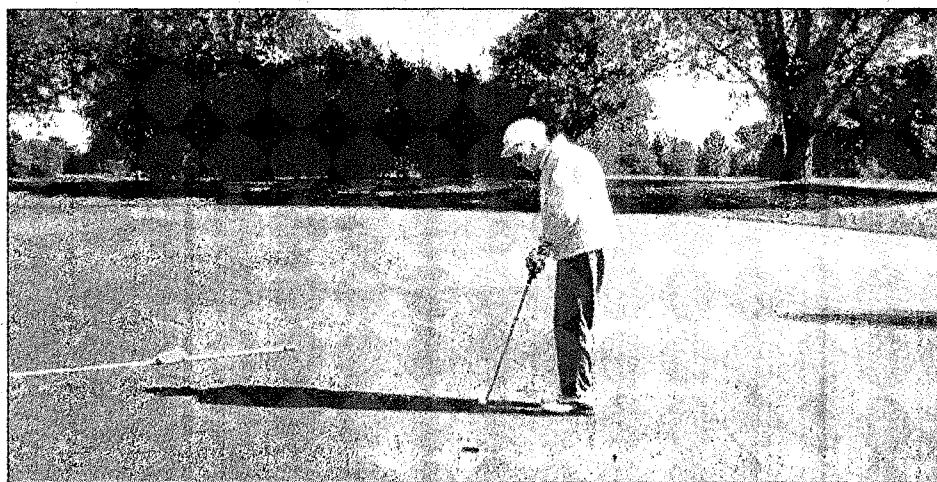

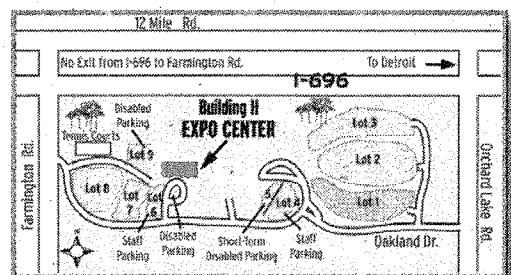

# With or without? Seguin's return in doubt for 2010-11 Whalers

Even though Tyler Seguin is still on the Plymouth Whalers roster, everybody connected with the Ontario Hockey League team knows that's just a technicality.

A new wave of Whalers is rolling into Compuware Arena, led by 16-year-old defenseman Max Iafate of Livonia (the team's No. 1 draft pick of 2010) and second-round pick Tom Wilson, a promising right winger.

Compuware fans will get to see those two players beginning 7 p.m. Saturday against Barrie — following road games Thursday and Friday to open the 2010-11 season.

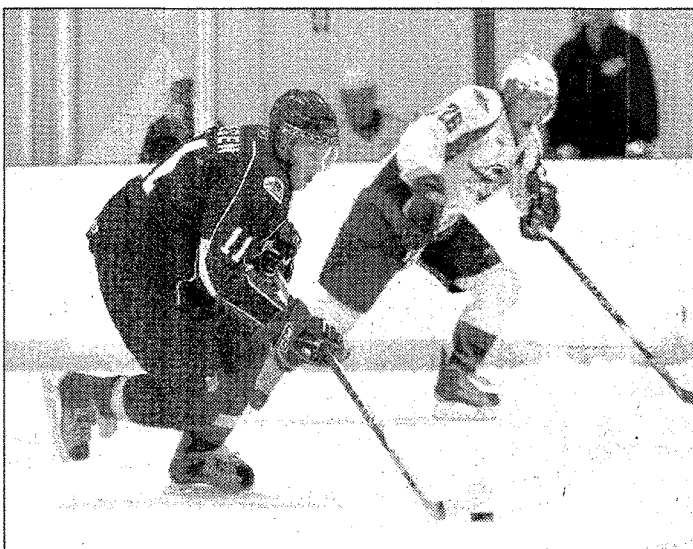
Of course, those fans couldn't be blamed one bit for hoping to again cheer for Seguin, the high-scoring center who was drafted by the Boston Bruins of the NHL. That probably won't happen, however.

"If he (Seguin) sticks around for his 10th game (in the NHL) that means he's a Boston Bruin for the rest of the season," said Brian Sommariva, Whalers assistant general manager and a Plymouth resident. "He'll probably play up to nine and then they'll make a decision on it. But all signs look like he's going to stick in Boston."

### TURNING THE PAGE

That means life and hockey go on at Compuware without the No. 2 overall draft pick as well as other top performers from 2009-10. Goalie Matt Hackett and forwards A.J. Jenks and Phil McRae have moved on to NHL organizations.

It should be interesting to see how the Whalers go about their business without Seguin (who tied Windsor's Taylor Hall in scoring with 106 points) and the others.

If the team's formidable 20-year history is any indication, opponents should expect them to at least find their way into the postseason.

Plymouth finished second in the Western Conference-West Division with 79 points last year, before bowing out to eventual Memorial Cup Windsor in the second round of the OHL playoffs.

"I think the players we're returning saw what a Memorial Cup team looks like, they saw it two years in a row by watching Windsor," Sommariva said. "I think our players need to realize the sacrifices Windsor's players made and we need to adopt those."

Complicating matters even more for head coach and general manager Mike Vellucci, Sommariva, associate coach Joe Stefan and others is the fact a handful of '09-10 players who can return to the Whalers also are tied

up with NHL clubs.

Those include center Robbie Czarnik (Los Angeles), Farmington Hills native and defenseman Austin Levi (Carolina), goalie Scott Wedgewood (New Jersey), forwards James Livingston (Edmonton) and Tyler Brown, the latter who went to Pittsburgh's camp on a tryout.

"He was at rookie camp and was just invited to the main camp," said Sommariva about the speedy Brown (14 goals, 25 assists, 39 points last year). "We heard that he's done real well there."

Czarnik (17-32-49), Livingston (17-18-35) and Brown would bring leadership to the Plymouth fold as overage players (OAs, players who start the season age 20) if they are sent back to the OHL.

"When you have the possibility of three or four OAs coming back, or not coming back, that can sort of make or break your season,"

Sommariva said. "So we're just hanging on and seeing what happens with the NHL and go from there."

### INCOMING TALENT

Sommariva said young Iafate and Wilson (drafted 27th overall) are part of an incoming nucleus of players who have outstanding work ethic and potential to be core players in Plymouth.

"Max is our first-round draft pick, he's got incredible upside," Sommariva said. "He's one of the better skaters in the draft, one of the best shots in the draft."

"We're just going to have to teach him some of the finer points of the game, but he's got all the tools."

As for Wilson (6-4, 195), he was projected as a first-round in the OHL draft, but remained on the boards when Plymouth picked in the second round.

"We were absolutely elated we got him in the second because he's a high-skilled forward, a big guy, he competes and we think he'll be a big part of our future. Hopefully, he'll be an NHL player one day."

Iafate already is a physical presence (6-2, 220) who will be on the top defensive pairings along with Levi (6-4, 190), Jay Gilbert (6-2, 205) and Beau Schmitz (5-11, 195).

Levi will bring a booming point shot to the power play, too.

"We're looking to get some production on the power play from Austin," Sommariva added. "He's got a great shot and it's a shot not too many guys want to block."

Plymouth's defense will have plenty of depth. Other players who Vellucci could give plenty of ice time to include Colin MacDonald, Nick Malysa and Clarkston native Josh Bemis.

# Dog town

## Canine walk debuts in Plymouth's Old Village

About 100 walkers have pre-registered up to help launch the first annual Barktober Fest in The Old Village Plymouth. At least a dozen of them don't even own dogs to take along on the 2½-mile walk for canines and their companions.

But event organizer Amy Rector isn't surprised. She says the combination of a "good cause," and a leisurely stroll among the "great old architecture and houses" of Old Village makes Barktober Fest the place to be at 10 a.m. on Saturday, Oct. 2.

"This was my little idea and it has ended up being quite a large idea," said Rector, a resident who attends Plymouth Old Village Association meetings, the walk beneficiary along with Homeward Bound Rescue League in Canton. "We've got great people in the community and the city of Plymouth has been fantastic. They've done everything in their power to get this event off the ground."

Participants, both those who pre-registered by Sept. 11, and those registering on site, will sign in beginning at 8:45 a.m. on Liberty, between Mill and Starkweather. The walk fee is \$25 and includes a T-shirt while supplies last. The first 150 to check in will receive a goody bag filled with coupons for pet-related services, toys, treats, chew bones and shampoos.

"I thought it was the coolest thing — Rachel Ray and Ellen Degeneres sent their dog food," Rector said. Pet adoptions and vendors will be on site until noon.

Scott Farmer, an Old Village resident and association president, said a former member suggested the walk

a few years ago, but the organization was spread "too thin" and unable to proceed with the event. It also presents an annual Halloween party and summer car and motorcycle show.

"The ball dropped and Amy picked it up and ran with it," Farmer said. "Really, it's Amy's event and Old Village Association took a supporting role."

"Plymouth, as a whole, is a dog-friendly place. Myself and all my neighbors own a dog. It (Barktober Fest) seems like a good fit for us."

He said the association's share of the walk proceeds likely will go into beautification projects, such as tree planting or signs.

### WISH LIST

Rector, a nursing clinical manager at Detroit Medical Center, owns a rescued dog and participates in other canine walks in the metro area. She hopes to make Barktober Fest an annual event.

"We've done a lot of beautification in the community. We don't have a big

bank account, but whatever we gain we give back," she said, adding that the association's wish list includes banners.

Teri Daniels, a Homeward Bound member, said the group's dream list includes a transport van to help volunteers rescue more dogs and a storage shed to hold the many different brands of dog foods that individuals donate.

"We're limited in how many dogs we can handle. There's an organization in Ohio, if we need a van, they'll let us

bring it up here. But it has their logos on it. We want people to realize we don't just rescue, but we're all about spay and neuter."

Her ultimate dream is for a transport van that's stocked with kennel cages, emergency food, water facilities, and items for emergency vet care.

In the meantime, proceeds raised from the walk will help the group continue to rescue, feed, provide veterinary care and spay and neuter services for adoptable dogs.

She said Homeward Bound rescues dogs from breeding facilities, takes owner surrenders and strays. Its foster network has some 100 dogs in private homes. When it was founded six years ago it found homes for about 150 dogs. Now it adopts out between 400-500 dogs annually.

"For every dog that goes out we get a dog that comes in. We rescued 96 dogs and needed emergency foster homes. The public stepped up. The problem was that once (the dogs) got homes, these temporary emergency fosters feel off too. Right now we're in dire need of foster homes."

The group seeks individuals or families with time and patience for fostering. Foster parents attend adoption events and help train and socialize their charges.

"I don't know of any organization that will go to the length we do. We're 100 percent no kill. And we take any and all breeds of dogs. It doesn't matter if it's a Bull Mastiff or a Pit bull."

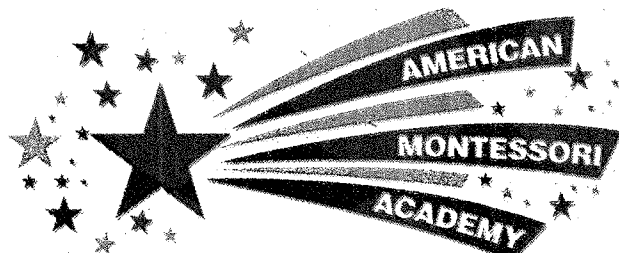

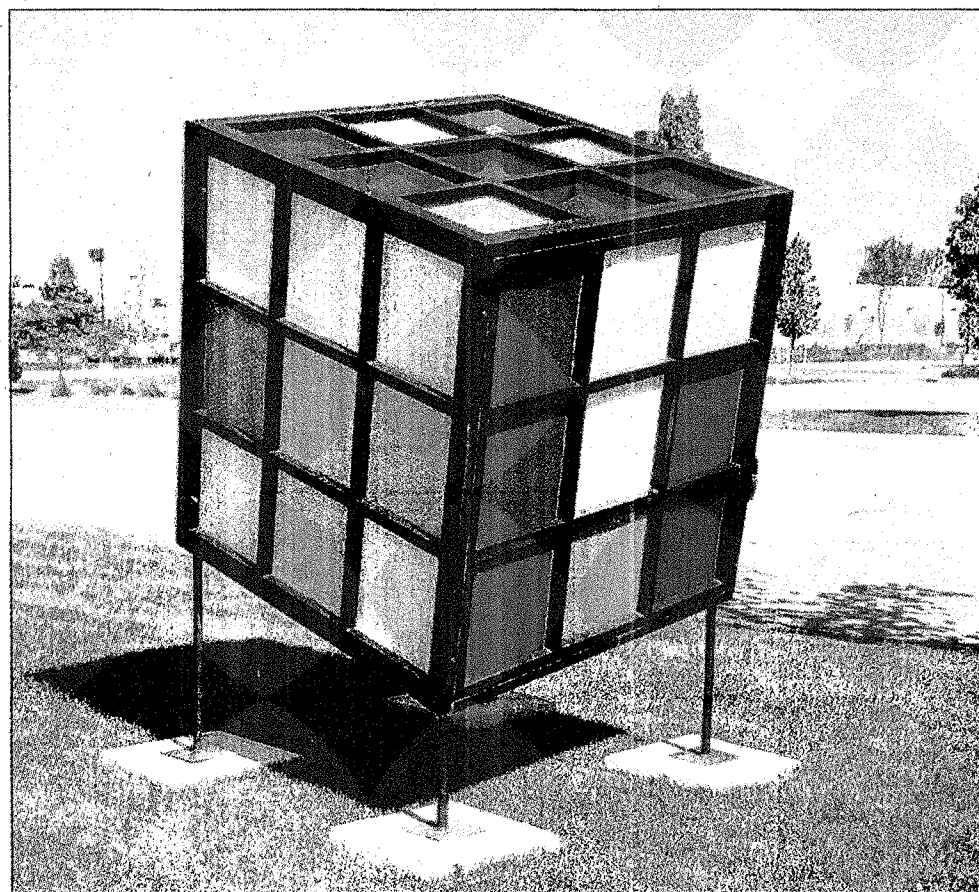

## TREATING THE PAIN OF ARTHRITIS

Treating pain in arthritis is different from attending to the aftermath of a fracture or a pulled wisdom tooth. The difference is in time that the patient needs treatment. Osteoarthritis, rheumatoid arthritis, psoriatic arthritis and lupus arthritis are representative of conditions that may cause recurring pain over a long foreseeable future.

Although the drugs we have today to reduce inflammation and its attending pain are excellent, these drugs are not perfect. Even with the best arthritis regimen a patient may experience pain that needs medication for relief.

A physician treating arthritis pain must walk a careful path. Medication such as acetaminophen, ibuprofen or aspirin may be insufficiently strong to resolve the pain. Yet, the physician finds long term use of narcotics such as vicodin and percocet inadvisable. These medications can interfere with proper gait and equilibrium, can slow respiration, and cause profound constipation.

At times, injecting steroids into a joint will end an attack of pain. At other times, the doctor may give a large dose of oral steroids and taper quickly. Using oral steroids may give a temporary respite from pain but repeated use brings out the unwanted side effects of cortisone.

The physician's shifting stance on treatment for arthritic pain represents a compromise among different therapies. Each treatment, if used alone, would not suffice over time, but the same therapy, if alternated with other pain medications can bring the patient relief repeatedly.

## Consider tooth health in lunch picks

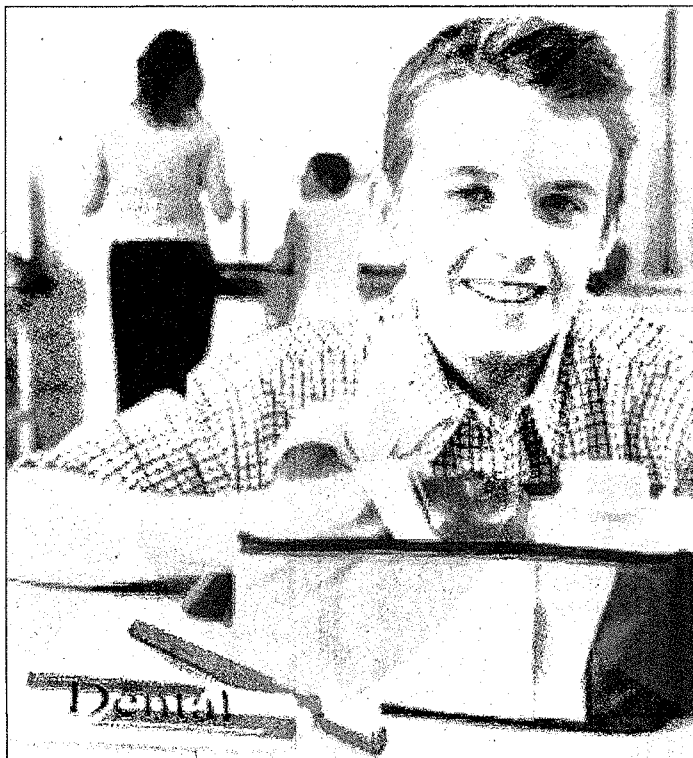
Think you're sending your kids to school with a healthy lunch?

Think again. Some popular lunch items can contain almost as much sugar as a lunch box full of candy bars, according to Delta Dental of Michigan.

"Common lunch foods actually contain a shocking amount of sugar," said Dr. Jed Jacobson, chief science officer and senior vice president at Delta Dental of Michigan. "With small changes, it is surprisingly easy to pack a lunch that is healthier overall and better for your child's teeth."

Consider a lunch with a packaged ham, cheese and crackers meal, a small can of diced peaches, fruit snacks, and a juice box. While it seems healthy and balanced, the sugar count is a whopping 62 grams. An average candy bar contains about 25 grams of sugar.

A few substitutes can reduce the sugar count tremendously. Switch to a ham and cheese sandwich on wheat bread and skip the fruit snacks. In addition to high sugar content, their stickiness holds sugars against teeth for prolonged periods.



Swap out the juice for a kid-sized sports drink or milk and opt for fresh fruits or vegetables instead of canned. These small changes bring this lunch's sugar total down to a more tooth-tolerable 19 grams.

For other teeth-friendly substitutes, consider yogurt as a good option for boosting calcium with only 10 grams of sugar. Even better is string cheese, which also offers calcium but with zero grams of sugar. For a special treat, vanilla wafer cookies have less than half the sugar of chocolate, crème-filled cookies. Potato chips, pretzels and cheesy crackers are good options for low-sugar items.

"Check the nutrition labels on the foods you buy to make sure you know what your kids are eating," Jacobson said. "A healthy and nutritious diet paired with good oral hygiene at home and visits to the dentist can go a long way toward protecting against tooth decay."

If possible, kids should brush their teeth after lunch at school. Keeping a toothbrush and travel-sized tube of toothpaste in a lunch box, desk or locker is a convenient way to encourage this healthy habit. If kids can't brush at school, Jacobson recommends having them rinse their mouths with water or milk after lunch.

Jacobson suggest parents try to avoid packing these high-sugar lunch items:

- Can of pop (40g)
- Fig cookies (23g)
- Chocolate-hazelnut spread (21g)
- Granola bars (19g)
- Pudding (17g)

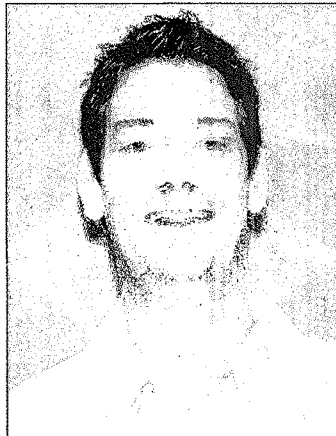

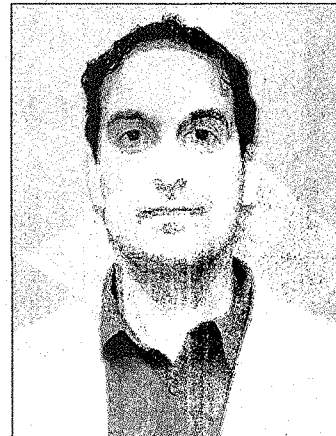

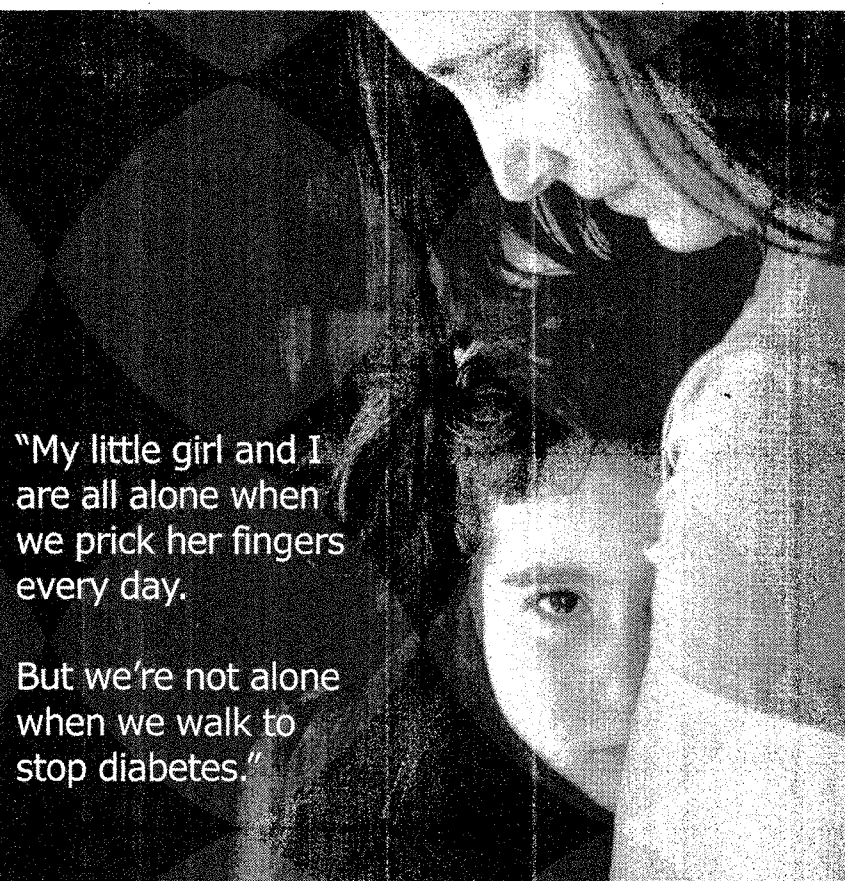
